14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The Board of Supervisors hereby adopts and implements the Second
16 Amendment to the 2018-2021 Memorandum of Understanding (“MOU”) between the City and
17 County of San Francisco and the San Francisco Fire Fighters Union, Local 798, Unit 2, to
18 update the Union Security and Surf Rescue Premium provisions.

19 The Second Amendment to the MOU so implemented is on file with the Clerk of the
20 Board of Supervisors in Board File No. 190833.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

24 Section 3. Effective Date. This ordinance shall become effective upon enactment.


