City and County of San Francisco, et al.; the lawsuit involves dangerous condition of public property and inverse condemnation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>The Roman Catholic Archbishop of San Francisco</u>, et al. v.
