12 **Janelle White (residency requirement waived), seat 1, inaugural term, shall be held by**
13 **a current or former employee, officer, or volunteer at a rape crisis center in the Bay Area, with**
14 **experience or expertise in prevention, education, outreach, resources, and services (or**
15 **survivors of sexual assault), appointed by the Board of Supervisors, for an indefinite term.**

16 **Denise Sicat Wong (residency requirement waived), seat 2, inaugural term, shall be**
17 **held by a person with experience as a peer educator addressing prevention, education, or**
18 **outreach regarding sexual assault, appointed by the Board of Supervisors, for an indefinite**
19 **term.**

20 **J. Ocean Mottley (residency requirement waived), seat 3, inaugural term, shall be held**
21 **by an advocate for survivors or witnesses of sexual assault, with expertise or experience in**
22 **criminal justice proceedings or resources and support services (or survivors of sexual**
23 **assault), appointed by the Board of Supervisors, for an indefinite term.**

1 Amelia Gilbert, seat 4, inaugural term, shall be held by a survivor of sexual assault or
2 an employee or representative from an organization that represents or counsels survivors,
3 appointed by the Board of Supervisors, for an indefinite term.

4 Denise Caramagno (residency requirement waived), seat 5, inaugural term, shall be
5 held by an employee, officer, or other representative of a local college, university, or other
6 institution of higher education in the City, with experience or expertise in protocols, laws, and
7 resources addressing sexual assault on campus, appointed by the Board of Supervisors, for
8 an indefinite term.

9 Leslie Simon, seat 6, inaugural term, shall be held by an employee, officer, or other
10 representative of a local college, university, or other institution of higher education in the City,
11 with experience or expertise in protocols, laws, and resources addressing sexual assault on
12 campus, appointed by the Board of Supervisors, for an indefinite term.

13 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Safer Schools Sexual Assault Task Force has a goal to be
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicants Janelle White, Denise Sicat Wong, J. Ocean Mottley, and Denise
17 Caramagno, who are not residents of San Francisco, are persons with experience that
18 uniquely qualifies them to serve on the Safer Schools Sexual Assault Task Force.
- 19 3. The Safer Schools Sexual Assault Task Force has attempted to fill the positions, for
20 which Janelle White, Denise Sicat Wong, J. Ocean Mottley, and Denise Caramagno
21 were nominated, with individuals who are City residents and who have the specific
22 experience, skills, and qualifications, but has been unable to do so at this time. The
23 Rules Committee has certified that Janelle White, Denise Sicat Wong, J. Ocean
24 Mottley, and Denise Caramagno are qualified to serve on the Safer Schools Sexual
25 Assault Task Force.

The eldest daughter of Taiwanese immigrants, I am currently the Vice President for Student Affairs & Enrollment Management and the designated campus Title IX Coordinator and Discrimination, Harassment & Retaliation Administrator at San Francisco State University. I was also an Associate Professor of Women's Studies at ASU and was tenured as an Associate Professor in Public Health Leadership & Education in UH Hilo's College of Pharmacy. As a nationally-sought after speaker and trainer in the areas of violence prevention, social justice, and leadership, I have delivered over 2,400 presentations, keynoted over 50 conferences and meetings, and authored several book chapters on these content areas. I am a former consulting editor for the Journal of American College Health (2000-2008) and was recognized as a Fellow by the America College Health Association in 2006. I recently served on the Advisory Board for the National Association of Student Personnel Administrators' Center for Scholarship, Research & Professional Development for Women and am now a member of the Women's Network Executive Council for the American Council on Education's Inclusive Excellence Group. I hold a BA in Psychology from Amherst College, a Master's in Public Health from Yale University, and a PhD in Educational Leadership & Research from Louisiana State University in Baton Rouge.

I am submitting my application for the Sexual Assault Task Force because I have dedicated my entire professional career to the prevention and intervention of sexual violence, and am seeking a way to actively serve the Bay Area community in this regard. I myself am a survivor of campus rape, and my first full-time professional job after graduate school was as a counselor/coordinator in a rape crisis center. I went on to serve in the field of college health where I worked on sexual assault policy development, cutting-edge prevention education (including the establishment of men's groups), and building campus-community coalitions to address sexual violence more comprehensively. My other roles in higher education administration have also involved investigation of sexual misconduct cases, as well as providing crisis advocacy and remedies for victims/survivors of sexual assault. My current role positions me to be an institutional and community champion on issues of gender equity, as well as to advance systemic policies/programs designed to end sexual violence.

I am excited about the potential opportunity to serve on the Safer Schools Sexual Assault Task Force. I understand that applications will be considered at the upcoming Rules Committee meeting on Thursday, September 22nd. I apologize that I will not be able to attend, as I was prior scheduled to attend the California State University Graduation Initiative 2025 Symposium in Long Beach on this date.

I have reattached my application materials for your quick reference. I would like to reiterate my strong interest in serving the greater San Francisco/Bay Area community in this capacity. I myself am a survivor of college rape – I was assaulted by an acquaintance during my freshmen year. Since then, I have devoted my entire professional career to work towards the intervention and prevention of sexual violence on campuses and in the broader community. I was an activist while an undergraduate and graduate student, and following receipt of my graduate degree, began work as a rape crisis counselor in a YWCA. From there, I moved into the area of prevention work in the university setting and have never turned back.

Throughout roles/responsibilities at six different campuses, I have worked to serve as a voice within higher education institutions on behalf of victims/survivors to ensure they are treated with care, compassion and dignity, and with all students to engage them as active partners in efforts to end sexual violence – with a special emphasis on working with college men. Relative to addressing campus sexual misconduct and sexual violence, I have extensive experience in legislative and institutional policy analysis/review, prevention program development and delivery for students, staff/faculty training (including with law enforcement), communications and media advocacy, victim/survivor advocacy/support, and perpetrator adjudication and sanctioning. I currently serve as the Title IX Coordinator for San Francisco State University, as part of my responsibilities as the Vice President for Student Affairs & Enrollment Management. In addition, I have served as a technical assistance consultant and speaker/trainer at numerous state, regional and national meetings/conferences on issues of sexual violence prevention/intervention, as well as authored several book chapters and articles on these issues.

I especially would like to serve on this Task Force because while I think colleges and universities should play a significant, visible and leading role in efforts to eradicate sexual violence in our communities, I do not believe we can do it alone. The attitudes, behaviors and beliefs that undergird sexual violence are socialized in us from childhood, and embedded in many institutions in our country – education, medical care, legal system, law enforcement, corporations, churches, media, just to name some. For our efforts to make an impact, we have to engage entire communities, not just parts of them. I have a particular interest in partnering with the K-12 educational entities.

Personal Statement / Natasha Singh

I'm a survivor of repeated sexual assaults. From my own experiences, which I will not detail here, I have harnessed my grief and outrage in the service of preventing violence against women and have had a life-long commitment to ending violence against women in its many forms, so that all women can be safe and free.

You'll see from my resume that I am involved in these issues in a number of ways; I serve as co chair of Center for Domestic Peace, an organization dedicated to ending domestic violence in Marin and beyond; I'm a certified domestic violence advocate; I'm a volunteer in-training on the crisis hotline, which responds to women fleeing domestic and sexual violence; I serve as Executive Director at Asha Rising, which provides safe housing for women who have aged out of the sex industry. I work as a consultant to schools where I train teachers to teach about consent and healthy relationships. My work, which includes teaching and lecturing, allows me to talk to youth ages 8 through 19, their parents, school administrators, and communities about the efforts we can all make to prevent sexual violence and transform our world.

While it's true that I have been interested in these issues for a long time, the importance and urgency of them was sharpened for me a few years ago after the Delhi gang rape—and after a student of mine reported to me that she'd been the victim of statutory rape. These events—and their aftermath—returned me not only to my own experiences of rape, but also to my determination to end gender-based violence. While the mass protests in India and the remarkable momentum in the US on behalf of survivors makes me believe we are in the middle of a genuine sea change, I'm also cognizant that so much more work needs to be done—and I'm excited to do it.

In India, the Verma Report (commissioned by the PM after the Delhi gang-rape) recommended significant changes to the definition of sexual assault and called for the implementation of fast-track courts and sensitivity training for police and the judiciary. In spite of these forward strides that were made, marital rape continues to be legal in India. Further, gender specific language in the law allows for only females to be considered victims of sexual assault, thereby excluding boys, men, and trans people. In California, we are seeing remarkable changes and pioneering efforts that may well galvanize the rest of the country—and even the world—to follow suit. Colleges and universities are now having to reckon with the “yes means yes” legal standard and take responsibility for educating students about consent; public schools have been mandated to join colleges in the effort to teach the distinction between sexual consent and sexual assault. The recognition that this kind of education must start much earlier, when youth are still developing their ideas about sexual intimacy and ethics, seems to be a critical step in prevention efforts and social transformation.

From the standpoint of a survivor, educator, feminist, and activist, I'm thrilled to see California leading the way in these efforts—and would be honored to be one of the voices at this table.



Over the past two years, I have seen Ocean Mottley do great things to help prevent gendered violence and educate vulnerable people (in my case, women and trans folks) on how to protect themselves.

I have worked with Ocean as both a student and instructor in self-defense courses for Girl Army, a collective that runs out of Suigetsukan Dojo in Oakland, California. He has worked with the collective as an in-class attacker. The importance of having a cis-gendered man with an extensive martial arts background who is a knowledgeable, sympathetic, and committed ally cannot be overstated. This role helps women and trans folk practice the physical and psychological skills they've learned in a more realistic (but still controlled and protected) way. Being able to practice the skills they've learned in a realistic yet controlled environment is especially important for students who are triggered by past trauma, including and especially sexual violence.

The in-class attacker role is not easy. It involves being both an ally, and also modeling the harassment that they are working to prevent. At the same time! All while staying calm and also protecting themselves, because many students do not have self-defense experience and may be triggered by the practice scenarios. Ocean has been excellent in this role, which could bring invaluable experience and knowledge to this Sexual Assault Task Force.

I was sexually assaulted in San Francisco on October 30, 2014. I was out with friends listening to music on a Thursday night, was drugged, and woke up in a stranger's apartment with two men raping me. I did all of the things someone is supposed to do: I was treated for a concussion and head-to-toe bruising, got a rape kit, filed a police report, pressed charges. Sixteen months later, the SF DA's office said they were not going to pursue a case against my assailants because it was my word against theirs. The experience was horrible beyond what I could have imagined, but I'm grateful to have had insight into this issue. I had strong support from my friends and family (many are not so fortunate), and made healing a priority. I have leveraging many therapies, and have used my story to help others. Last summer, I founded a civic innovation lab with two tech projects: 1) an app to support sexual assault survivors by connecting them to one another and to curated resources to help them heal, and 2) a law enforcement case management software to track rape kits, and enable victims to opt-in to receive automatic notifications of any chance to their case/evidence. I believe I can bring significant value and energy to this taskforce and to the issue, from the local to the national levels.

Business and/or professional experience:

I started my company, Vivifi Studio, last year after finishing grad school and moving back to SF (I still technically haven't graduated due to needing to take time off following my assault). I studied business at the Tuck School of Business at Dartmouth and Harvard Kennedy School of Government. My master's thesis at Harvard was focused on the economic impact of sexual assault on survivors and society at large. Prior to graduate school, I worked in the federal government at the U.S. Department of Homeland Security (where I served on DHS's Blue Campaign to fight human trafficking), and before that at the non-profit, non-partisan Partnership for Public Service.

I currently serve on the research team of Rise, Inc., a non-profit organization working to advance a sexual assault survivor's bill of rights across the country. I have previously served as a volunteer with Oxfam Japan, Amnesty International and DC Stop Modern Slavery. 



At Project SURVIVE, I learned to view sexual violence and intimate partner violence through feminist, sociological, and public health lenses. The courses offered hope for social change and a space to recognize and respect the strength and resilience of survivors.

It was amazing to be in a class where women, trans folks, and men could dialogue openly about how sexual violations have impacted our psyches. We shared experiences that our culture would prefer remain shrouded in victim-blaming, and cloaked in shame, and instead turned isolation into community, and then into healing.

Doing the actual fieldwork was profoundly meaningful for me: talking with college peers and high school youth—to debunk harmful myths and stereotypes, to dialogue in a sex-positive framework about healthy, safer sex, and to discuss the power dynamics and behavioral patterns of abusers. I believe if I had seen a presentation like the one for youth when I was in high school, I could have recognized red flags and avoided harmful people.

While Project SURVIVE has helped me further my academic and career goals, its most profound impact has been developmental. I learned emotionally what I already knew intellectually—people heal from trauma. Using critical analysis, with the intention and resolve to go back into their communities, and work with people facing similar struggles, survivors come “full circle.”

One of Project SURVIVE’s greatest gifts was helping me to contextualize my life. There are political, structural reasons behind interpersonal violence. The wisdom of survivors, resilient beyond description, propels us into social change. People heal in safe, supportive spaces. If you can't find one, you can make one. I found one in Project SURVIVE.

I know Leslie has received multiple “Hero” awards for starting and running the program—writing grants, training presenters, finding presentation school sites, teaching the classes—and Leslie is a hero for me, and many others. I also know that she is grateful for the community we have created in collaboration with her.

In 2004, I took Politics of Sexual Violence at City College of San Francisco. It spoke to me in a visceral, meaningful way, exploring things I had thought and felt but had no words for, no voice to speak them. As a survivor, connecting people with information and support has been incredibly rewarding. Finding this program and learning from Leslie Simon was like an unexpected gift at a time when I most needed it.

Project SURVIVE teaches us to own our identities and our stories, to heal and to be active agents in changing the system. It empowered me to join a community that engages with issues we are often frightened to discuss.

Project SURVIVE has stayed with me: it connected me to domestic violence movement activism, and the tenets of the program served me at Mills College where I majored in Ethnic Studies. Project SURVIVE has influenced my writing by inspiring me to focus on my family's legacy of trauma and its healing.

Being a peer educator instilled a passion in me for connecting academia to grassroots activism. The first Intersecting Identities conference was born through Project SURVIVE. Soon, the tenth annual conference will be held. In 2008, I collaborated with Leslie on Murder in the Margins: Systems of Global Exploitation, a conference focused on the femicides in Mexico, Guatemala, and Canada.

Things have come full circle. Ten years after first taking Leslie Simon's class, I am teaching Trauma and the Arts at City College. In Trauma and the Arts, like Project SURVIVE, we honor survivors' words and experiences and discuss creative avenues to tell stories and heal.

Reflecting on a program that has served such a diverse community for 20 years is both humbling and heartening. Project SURVIVE influenced the paths I have walked so far, and I will carry it with me wherever I head in the future.

Professionally, Project SURVIVE has furthered my career, and I currently hold a program coordinator position working with a wonderful LGBTQQ youth organization, educating youth in the San Francisco Unified School District about the intersecting identities we all hold in regards to race, gender, culture, and sexual orientation. The program is about empowering students through social justice education through a queer lens.

I also intend to further my career using many of the tools Project SURVIVE gave me. I plan on creating workshops and/or seminars for youth, specifically queer youth, focusing on healthy relationship dynamics and healing from trauma due to emotional, physical, and sexual violence.

Project SURVIVE empowered me to acknowledge my experiences, allowed me to find my voice to share those experiences, and helped me educate and empower other folks who are also survivors. I learned how to advocate for others and myself, provide support for those on their healing journey, and to pay attention to the importance of self-care.

I first became involved with Project SURVIVE in 1996. I was 21 years old and in a difficult time in my life. Project SURVIVE gave me the support and tools I needed. Though I am a man, I found a community of commonality that I never expected.

I was having a hard time staying in school despite having an aptitude and hunger for learning. I was troubled by the over-intellectualization of education and what appeared to be a machine for processing students into the labor market. I remember the day I decided to take my first Project SURVIVE class. I found a flier advertising the introductory class: Politics of Sexual Violence. What a novel idea, I said, sotto voce, a class on politics, sex, and violence. It turned out to be exactly what I needed. The class helped me, intellectually and emotionally, to understand the violence and anger in my home growing up as well as the violence in the larger world. We talked about our lives and learned from others. Then, we spread the word. Being able to engage seriously with other students about healthy relationships enriched my education.

Relationships are the most important part of my life, not just sexual relationships, but all the interactions I have with friends, family, neighbors, co-workers. Project SURVIVE gave me healthy communication tools. Through this life-long learning process I continue to struggle and grow with the help of what I learned almost 20 years ago.

The program also kept me in school by helping me find a reason to care about education and to excel. I eventually transferred to UC Berkeley where I received my bachelor's degree. Having to work with other students collaboratively and get up in front of strangers to talk about a difficult topic, often with people who disagreed with me, helped prepare me for my career today as an attorney.

Project SURVIVE has changed my life in so many ways. A former instructor directed me to the program because I had been sexually assaulted and was broken--mentally, emotionally, and spiritually.

Speaking with Leslie Simon, I got more insight into what the program provides for students. She also educated me briefly on the politics of the law concerning not only domestic violence but sexual assault as well. This gave me an understanding of why my attacker was never charged. I decided to take the Project SURVIVE training classes--Politics of Sexual Violence and Ending Sexual Violence: Peer Education, which proved the best form of therapy to help overcome what had happened to me.

Hearing stories, being able to speak in a forum, and meeting so many different and brave women helped me to grow and be strong. I learned I was not alone, and my feelings were validated. I needed this deeper understanding because I grew up around women who were abused. I even watched one of my own loved ones get physically assaulted by her lover, something I still have nightmares over. It has taught me that I have a right to say no and NOT to tolerate any abuse.

After graduating with two Associate's Degrees, one in Social & Behavioral Sciences and the other in Computer Networking & Information Technology, I am currently a student at California State University, East Bay, majoring in Human Development, with an emphasis in Women's Studies. Also, I participate in my church's Women's Department Support Group, The Sisterhood. We talk about women keeping faith in God, and we also discuss community issues, such as health, love, relationships, and domestic violence. I am happy to be a part of something that I have a passion for.

Project SURVIVE has helped me grow mentally, emotionally, and spiritually.

Thank you for supporting the establishment of the Safer Schools Sexual Assault Task Force. I am pleased that San Francisco is taking seriously recent national and state legislation addressing the epidemic of sexual violence on college and university campuses.

I am writing as Dean of the School of Behavioral and Social Sciences and Multicultural Studies at City College of San Francisco to recommend Leslie Simon, long-time instructor, former Women's Studies chair, and current Project SURVIVE coordinator at City College of San Francisco, to the Task Force.

Project SURVIVE is the college's sexual violence prevention program. It received mention as a notable program in the "Theory and Practice" column of the Ms. 2009 "Guide to Women's Studies," and this past January Project SURVIVE won an honorable mention in the California Academic State exemplary awards competition.

Leslie Simon has continued to expand the program since she founded it in 1994. The Project SURVIVE peer educators make presentations at multiple City College sites, serving the diverse San Francisco communities. They also make presentations to San Francisco public high schools all of which feed into City College through the Expect Respect SF (ERSF) college and community collaborative.

When SFUSD unveiled its new sexual health "Be Real, Be Ready." curriculum a couple of years ago, ERSF became the preferred provider for the dating violence prevention modules. Evaluation reports from the Department of Public Health are positive, and SFUSD is proud to be partnering with City College through this program.

In 2003-2004, Project SURVIVE translated its materials into Spanish and Chinese and began making multi-lingual presentations in English-Spanish and English-Cantonese-Mandarin at our Mission and Chinatown sites. In 2011, the program received a grant from The Avon Foundation, which expanded the multi-lingual project so that at several City College sites serving English language learners, brochures in multiple languages informing students of resources for sexual and domestic violence are available on an ongoing basis in prominent locations.

Ms. Simon is committed to ending sexual and domestic violence and also dedicated to the promotion of healthy relationships as well as the prevention of sexual violence. She has eagerly trained Project SURVIVE peer educators to promote AB 967, the California "Yes Means Yes" legislation.

We are thrilled that Project SURVIVE continues to serve our students so well, and I know Ms. Simon will bring to the Safer Schools Sexual Assault Task Force the dedication and expertise that has made Project SURVIVE the notable program that it is.

I am writing to strongly recommend Leslie Simon to serve on the Safer Schools Sexual Assault Task Force. As Women's Studies chair at City College of San Francisco, I supervise Ms. Simon in her position of coordinator of Project SURVIVE, the college's sexual violence prevention and healthy relationship promotion program. Ms. Simon founded the program in 1994, and since that time over 200 peer educators have presented more than 5,000 workshops to nearly 100,000 students. They visit a range of classrooms at the college including English, ESL, Health Education, Human Sexuality, Psychology, Sociology, and Learning Assistance. They visit all 9th grade Health Education classes in the San Francisco public high schools through the Project SURVIVE program and community collaborative, Expect Respect SF. Though other prevention programs existed at four-year colleges and universities at that time, Project SURVIVE was one of the first of its kind at a community college in the nation.

The core of the program is prevention education, which includes not only workshops to City College and SFUSD students, but also non-credit self-defense classes open to the community. Each academic year Project SURVIVE also offers multiple awareness programs to our campus community throughout the year, especially during Domestic Violence Awareness Month in October and Rape Awareness Month in April. These events include bystander intervention trainings, poetry and theater performances, and art installations. Although Ms. Simon offers short-term crisis counseling to survivors and has helped many of them heal from their traumas, she has dedicated her career to the field of prevention education and will be able to bring to the Task Force what she has learned training peer educators in "The Politics of Sexual Violence" and "Ending Sexual Violence: Peer Education"—both credit classes at City College.

Ms. Simon also coordinates the Sexual Health Educator Certificate at the college, which has enabled numerous students to gain employment in local prevention and intervention agencies and to transfer to four-year universities where they have majored in psychology, sociology, and health education, still dedicating much of their academic careers to sexual violence prevention. We are proud that a number of them have now received social work and public health master's degrees, and one of them is even a practicing attorney who has served as an advocate for a sexual violence victim.

During the 20th anniversary celebration of Project SURVIVE (PS), to which Congresswoman Jackie Speier sent a video greeting and at which Supervisor Jane Kim distributed awards to members of the PS community, I described Leslie Simon as a visionary. She is no less than that and will bring a hopeful, innovative, creative—as well as disciplined—voice to the work of the Task Force. I enthusiastically recommend her to you.



Report: The Task Force shall report to the Board of Supervisors no later than 12 months after the inaugural meeting. The written report shall analyze relevant State and federal laws regarding on-campus sexual assault, recommending best practices for colleges and universities in the City to reduce sexual assault, and recommending any steps that the City could take, including changes in law or policy, to assist those institutions toward that goal.

Sunset Date: Terminates 12 months after the Task Force's inaugural meeting. After expiration, and unless the Task Force is extended by ordinance, the City Attorney shall cause the removal of Sections 5.10-1 through 5.10-7 from the Administrative Code.
