8 Be it ordained by the People of the City and County of San Francisco:


9 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Kelly O'Haire v. City and County of  
11 San Francisco, et al., San Francisco Superior Court, Case No. CGC 13-531419 by the  
12 payment of \$725,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on May

15 Defendants City and County of San Francisco and Greg Suhr.


