5 and re-appropriating ~~\$8,500,000~~ \$6,672,963 to overtime in order to support the
6 department's projected increases in overtime as required per Ordinance 194-11, and
7 requires a two-thirds vote of all members of the Board of Supervisors for approval.**

2 the accounting treatment of sources and uses appropriated in this Ordinance as necessary to
3 conform with Generally Accepted Accounting Principles.

5 Section 4. The Fiscal Year 2011-12 Annual Appropriation Ordinance includes the
6 rejection of funding for \$407,000 in overtime and associated fringe benefits in the Fire
7 Department by the Board of Supervisors. Pursuant to Section 3.15 of the Administrative Code,
8 the funding of any item previously rejected or reduced by the Mayor or Board of Supervisors
9 in consideration of the annual budget shall require a two-thirds vote of all members of the
10 Board of Supervisors for approval.
