1 [Affirming the Exemption Determination - 1100 Lombard Street]

2  
3 **Motion affirming the determination by the Planning Department that the project located**  
4 **at 1100 Lombard Street is exempt from environmental review.**

5  
6 **WHEREAS,** On or about February 3, 2012, the Planning Department determined that a  
7 proposal to create a new firewall on the 1100 Lombard Street property was exempt from  
8 environmental review under the California Environmental Quality Act ("CEQA"), the CEQA  
9 Guidelines and San Francisco Administrative Code Chapter 31 as a Class 1 categorical  
10 exemption, a minor alteration to an existing structure (the "exemption determination"). By  
11 letter to the Clerk of the Board dated March 20, 2012, Christa Shaw, on behalf of the John  
12 Sperling Irrevocable Trust, owner of 2323 Hyde Street ("Appellant"), appealed the exemption  
13 determination; and

14 **WHEREAS,** on May 1, 2012, this Board held a duly noticed public hearing to consider  
15 the appeal of the exemption determination filed by Appellant, and following the public hearing  
16 affirmed the exemption determination; and

17 **WHEREAS,** In reviewing the appeal of the exemption determination, this Board  
18 reviewed and considered the exemption determination, the appeal letter, the responses to  
19 concerns document that the Planning Department prepared, the other written records before  
20 the Board of Supervisors and all of the public testimony made in support of and opposed to  
21 the exemption determination appeal. Following the conclusion of the public hearing, the  
22 Board of Supervisors affirmed the exemption determination for the Project based on the  
23 written record before the Board of Supervisors as well as all of the testimony at the public  
24 hearing in support of and opposed to the appeal. The written record and oral testimony in  
25 support of and opposed to the appeal and deliberation of the oral and written testimony at the

1 public hearing before the Board of Supervisors by all parties and the public in support of and  
2 opposed to the appeal of the exemption determination is in the Clerk of the Board of  
3 Supervisors File No. 120262 and is incorporated in this motion as though set forth in its  
4 entirety; now therefore be it

5         MOVED, That the Board of Supervisors of the City and County of San Francisco  
6 hereby adopts as its own and incorporates by reference in this motion, as though fully set  
7 forth, the exemption determination; and be it

8         FURTHER MOVED, That after carefully considering the appeal of the exemption  
9 determination, including the written information submitted to the Board of Supervisors and the  
10 public testimony presented to the Board of Supervisors at the hearing on the exemption  
11 determination, this Board concludes that the Project qualifies for a exemption determination  
12 under CEQA Guidelines Section 15301 and affirms the determination of the Planning  
13 Department .
