3 **Resolution consolidating the State General Election to be held in the City and County**

4 **of San Francisco on November 6, 2012, with the City and County of San Francisco**

5 **Municipal Election, San Francisco Unified School District Board of Education Election,**

6 **City College of San Francisco Governing Board Election, City and County of San**

7 **Francisco Special Bond Election, Bay Area Rapid Transit (BART) District Election, and**

8 **San Francisco Community College District special tax election, all to be held in the City**

9 **and County of San Francisco on the same date, and providing that the election**

10 **precincts, voting places, and officers for these elections shall be the same as for the**

11 **State General Election.**

13 WHEREAS, The State of California will hold a General Election on November 6, 2012,

14 for the purpose of voting on candidates for federal and state offices, as well as proposed state

15 ballot measures to be submitted to the voters; and

16 WHEREAS, The City and County of San Francisco will hold a municipal election on

17 November 6, 2012, for the purpose of voting on candidates for City offices, as well as

18 proposed local ballot measures to be submitted to the voters; and

19 WHEREAS, The San Francisco Community College District will hold an election on

20 November 6, 2012, for the purpose of voting on candidates for the Governing Board of the

21 Community College District; and

22 WHEREAS, The San Francisco Unified School District will hold an election on

23 November 6, 2012, for the purpose of voting on candidates for the Board of Education; and

24 WHEREAS, The Board of Supervisors called a special election to be held in the City

25 and County of San Francisco on November 6, 2012, for the purpose of voting on a proposed

1 general obligation bond measure, and consolidated the special municipal bond measure
2 election with the General Election scheduled for the same date; and

3 WHEREAS, The Bay Area Rapid Transit (BART) District Board of Directors will hold a
4 district election on November 6, 2012, for the purpose of voting on candidates for the BART
5 Board of Directors, and requested that the district election be consolidated with the General
6 Election scheduled for the same date; and

7 WHEREAS, The San Francisco Community College District Board of Trustees called a
8 special election to be held in the City and County of San Francisco on November 6, 2012, for
9 the purpose of voting on a proposed special tax measure, and requested that the special tax
10 measure election be consolidated with other elections to be held on the same date within the
11 City and County; and

12 WHEREAS, The Board of Supervisors believes that it is in the best interests of the
13 public that these elections be consolidated, as authorized by law; now, therefore, be it

14 RESOLVED, That pursuant to California Elections Code section 10400 et seq., the City
15 and County of San Francisco municipal election, San Francisco Unified School District Board
16 of Education election, City College of San Francisco Governing Board election, City and
17 County of San Francisco special municipal bond election, Bay Area Rapid Transit (BART)
18 District Election, and San Francisco Community College District special tax election to be held
19 in the City and County of San Francisco on November 6, 2012, shall be and hereby are
20 consolidated with the State General Election scheduled for the same date; and, be it

21 FURTHER RESOLVED, That pursuant to California Elections Code section 10002, the
22 San Francisco Community College District, San Francisco Unified School District, and the
23 BART District shall reimburse the City and County in full for the election services performed
24 for each district; and, be it

1 FURTHER RESOLVED, That the voting precincts, polling places, and officers of the
2 State General Election and the City and County of San Francisco municipal election, San
3 Francisco Unified School District Board of Education election, City College of San Francisco
4 Governing Board election, City and County of San Francisco special municipal bond election,
5 Bay Area Rapid Transit (BART) District Election, and San Francisco Community College
6 District special tax election shall, in every case, be the same; that there shall be only one set
7 of election officers in each precinct, to wit, the election officers to be appointed by the Director
8 of Elections for each precinct; that all candidates, ballot measures and bond proposals shall
9 be set forth on the ballots provided for said election; that the elections shall be held in all
10 respects as though there were only one election, and that all returns shall be canvassed by
11 the Director of Elections as provided in the California Elections Code.


