6 **filed on June 12, 2009, in San Francisco Superior Court, Case No. CGC-09-489400;**
7 **entitled Gilles Combrisson, et al. v. City and County of San Francisco, et al.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The City Attorney is hereby authorized to settle the action entitled "Gilles
11 Combrisson et al. v. City and County of San Francisco", San Francisco Superior Court Case
12 No CGC-09-489400 by the payment of an amount not to exceed \$320,000.

13 Section 2. The City Attorney is also hereby authorized to dismiss without prejudice
14 the cross complaint it filed on December 17, 2009, on behalf of the City and County of
15 San Francisco against Anthem Blue Cross Life and Health Insurance Company.

16 Section 3. The above-named action was filed in San Francisco Superior Court on June
17 12, 2009, and the following parties were named in the lawsuit: Gilles Combrisson, William
18 Phillips, Patrick Hagemeister, and Ranell Hansen, plaintiffs; the City and County of
