[Settlement of Lawsuit - Fireman's Fund Insurance Company - \$125,000]

Ordinance authorizing settlement of the lawsuit filed by Fireman's Fund Insurance Company against the City and County of San Francisco for \$125,000; the lawsuit was filed on July 17, 2014, in San Francisco Superior Court, Case No. CGC-14-540616; entitled <u>Fireman's Fund Insurance Company vs. Alliance of Event Planners and</u> Vendors, Inc., et al.; the lawsuit involves an insurance dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Fireman's Fund Insurance Company</u> <u>vs. Alliance of Event Planners and Vendors, Inc., et al.</u>, San Francisco Superior Court, Case No. CGC-14-540616 by the payment of \$125,000.
