City and County of San Francisco</u>, San Francisco Superior Court Case No. CPF-15-514532, by the payment of \$1,450,000 and San Francisco's dismissal of its cross-complaint in Case No. CPF-15-514532. These are suits for refund of Real Property Transfer Tax, Transient Occupancy Tax and Tourism Improvement District Fees.
