Faye-Denise Lacanilao, seat 6, succeeding Chuck Burwell, must be held by a person who advocates for the interests of pedestrians and bicyclists in the neighborhoods served by Balboa Park Station, for a one-year term ending February 28, 2018.

Aaron Goodman, seat 7, succeeding Christina Hue Dang, resigned, must be held by a resident of the neighborhoods served by Balboa Park Station, for a two-year term ending February 28, 2019.

Luis Licea, seat 8, succeeding Aaron Goodman, must be held by a person who owns or works for a small business or who advocates for community and economic development in the neighborhoods served by Balboa Park Station, for a one-year term ending February 28, 2018.

Jesse Fernandez, seat 9, succeeding Robert Muehlbauer, must be held by a representative of a nonprofit organization or community group that works on issues related to land use or housing in the neighborhoods served by Balboa Park Station, for a two-year term ending February 28, 2019.
