[Urging the Department of Public Health and the Health Service System to Provide Treatment for HIV-related Lipodystrophy Syndrome - Supporting California State Senate Bill 221 (Wiener)]

Resolution calling on the Department of Public Health and the Health Service system to provide access to treatment and coverage for HIV-related lipodystrophy syndrome; and supporting California State Senate Bill 134, authored by Senator Wiener, to require insurance providers in California to cover medical treatment for HIV-related lipodystrophy syndrome.

WHEREAS, San Francisco has long-been internationally recognized as a leader in the treatment and care of patients with HIV/AIDS; and

WHEREAS, The advancement of medical science over the years has significantly improved the efficacy of HIV treatment, leading to longer, healthier, and more fulfilling lives; and

WHEREAS, Improved treatment options including antiretroviral drug therapy have made HIV a long-term manageable disease, leaving patients to cope with other associated diseases, including lipodystrophy syndrome; and

WHEREAS, Lipodystrophy syndrome is a disturbance of fat metabolism that involves the abnormal deposition and distribution of fat in the body, with some areas of the body missing subcutaneous fat altogether and with other areas suffering large deposits; and

WHEREAS, Severe lipodystrophy is also a manifestation of insulin resistance and is associated with highly elevated triglyceride levels and fatty liver disease; and

WHEREAS, Lipodystrophy syndrome creates visible disfiguring and stigmatizing morphological changes in body shape and appearance, often including a fat pad on the neck (colloquially called "buffalo hump"), fat accumulation around the front of the neck and under

the chin (colloquially called "horse collar"), increased abdominal girth, and abnormal fat loss in the nasolabial folds of the face as well as in the limbs; and

WHEREAS, In addition to the physical impacts, lipodystrophy also causes severe psychological harm to people with HIV; and

WHEREAS, Although lipodystrophy syndrome is clearly associated with HIV and inexpensive and effective medical treatments currently exist, insurers routinely deny claims for treatment on the basis that they are cosmetic and not medically necessary; and

WHEREAS, In 2016, the Commonwealth of Massachusetts became the first State in the nation to require that public and private insurance providers cover medical treatments for HIV-associated lipodystrophy; and

WHEREAS, Most insurance and medical care providers in California, including private carriers and Medi-Cal, consider HIV-related lipodystrophy as a cosmetic issue and therefore do not provide coverage for treatment; and

WHEREAS, Healthy San Francisco and the San Francisco Health Service System do not cover, or provide access to treatment, for HIV related lipodystrophy; and

WHEREAS, California State Senator Wiener has introduced Senate Bill 221, which would mandate that treatment for HIV-related lipodystrophy syndrome be covered in California by both public and private insurance providers; now, therefore, be it

RESOLVED, That the Board of Supervisors, consistent with our shared values of being a world-leader in the treatment and care of HIV/AIDS patients and for the continued advocacy on their behalf, strongly urges the Department of Public Health to take the necessary steps to ensure that patients enrolled in Healthy San Francisco who suffer from HIV-related lipodystrophy are provided with access to care and that the San Francisco Health Service System do the same; and, be it

FURTHER RESOLVED, That the Board of Supervisors strongly supports California Senate Bill 221 (Wiener); and, be it

FURTHER RESOLVED, That the Board of Supervisors requests that the Clerk of the Board transmit the final approved resolution to the State Legislature, to the Department of Public Health, and to the San Francisco Health Service System.
