15	Be it ordained by the People of the City and County of San Francisco:				
16	Section 1. Findings.				
17	(a) The Planning Department has determined that the actions contemplated in this				
18	ordinance comply with the California Environmental Quality Act (California Public Resources				
19	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of				
20	Supervisors in File No. 170028 and is incorporated herein by reference. The Board affirms				
21	this determination.				
22	(b) On February 9, 2017, the Planning Commission, in Resolution No. 19851,				
23	adopted findings that the actions contemplated in this ordinance are consistent, on balance,				
24	with the City's General Plan and eight priority policies of Planning Code Section 101.1. The

- Board adopts these findings as its own. A copy of said Resolution Is on file with the Clerk of the Board of Supervisors in File No. 170028 and is incorporated herein by reference.
 - (c) <u>Pursuant to Planning Code Section 302, this Board finds that the Planning Code</u> and Zoning Map amendments will serve the public necessity, convenience, and welfare for the reasons set forth in Planning Commission Resolution No. 19851, and the Board incorporates such reasons herein by reference.
 - (d) The Board of Supervisors wishes to establish the Calle 24 Special Use District along and adjacent to the 24th Street corridor in the Mission District to balance preservation of the neighborhood character of the Calle 24 Latino Cultural District with accommodating new uses and recognizing the contributions of the Latino community to the neighborhood and San Francisco as a whole. The mix of businesses and uses, including Legacy Businesses, murals, festivals and architectural neighborhood design and character in the Calle 24 Special Use District contribute to a strong sense of neighborhood and a unifying identity. The variety of goods and services offered within the Calle 24 Special Use District serves the local needs of residents and visitors alike. Many of the businesses have been owned and operated by the same family for generations and have continued to serve the local needs of the community with their services, whether they be bakeries, butcher shops, grocery stores, salons, non-profit institutions, or restaurants. Currently there are at least 22 businesses and institutions on 24th Street that have been in operation for 30 years or more.
 - (de) 24th Street has retained much of its distinctive character and reputation as the cultural heart of the Mission, thanks to the corridor's unique mix of arts and cultural destinations, institutions, and murals and other public art. Moreover, the retail and restaurants in this neighborhood benefit from the visitors attracted by the arts and cultural institutions, murals, and public art along the corridor.

- (ef) As set forth in the Strategic Economics Calle 24 Retail Study (December 2016), while some of the arts and cultural organizations on the corridor serve a citywide or even regional constituency, the groceries, restaurants, and other retail establishments have historically served a primarily local customer base. Many restaurants, cafés, grocery stores, salons, and other businesses remain affordable and continue to serve the daily needs of residents from the Mission District and adjacent neighborhoods, even as the corridor attracts more visitors.
- (fg) Additionally, and as discussed the Strategic Economics Calle 24 Retail Study, the Calle 24 Special Use District area generally has smaller, narrower retail spaces than other parts of the Mission neighborhood, particularly compared to Mission Street. Smaller spaces tend to be more affordable overall than larger spaces and can serve both new, independent businesses with lower profit margins as well as more established businesses that do not require much space. At the same time, the small storefronts that are generally available on Calle 24 make the corridor a less attractive location for upscale or formula retailers and restaurants that require larger spaces to display their inventory or provide extensive seating for diners.
- (gh) Supporting these smaller, neighborhood-serving non-residential uses, including Legacy Businesses, and the cultural, arts, and institutional uses found in the Calle 24 corridor furthers the Planning Code Section 101.1(b) priority policy goals that "existing neighborhood-serving retail uses be preserved and enhanced and future opportunities for resident employment in and ownership of such businesses enhanced" and that "existing housing and neighborhood character be conserved and protected in order to preserve the cultural and economic diversity of our neighborhoods."
- (hi) According to a September 2014 report by San Francisco Architectural Heritage entitled "Sustaining San Francisco's Living History: 9 Strategies for Conserving Cultural

1	Heritage Assets," long-operating businesses foster civic engagement and pride as				
2	neighborhood gathering spots and contribute to the City's cultural identity. Additionally, the				
3	report found that many otherwise successful long-standing businesses are at risk of				
4	displacement, despite continued value and a record of success, due to San Francisco's				
5	current economic climate.				
6	(ij) San Francisco has established the Legacy Business Registry, maintained by the				
7	Office of Small Business, to recognize that these long-standing, community-serving				
8	businesses are a valuable cultural asset to the City. The controls included in the Calle 24				
9	Special Use District will further recognize and protect these important economic and cultural				
10	assets.				
11	Section 2. The Planning Code is hereby amended by adding Section 249.59 to read as				
12	follows:				
13	SEC. 249.59. CALLE 24 SPECIAL USE DISTRICT.				
14	(a) General. A Special Use District entitled the Calle 24 Special Use District, the				
15	boundaries of which are shown on Sectional Maps SU07 and SU08 of the Zoning Map, is hereby				
16	established for the purposes set forth below.				
17	(b) Purpose. The Calle 24 Special Use District is intended to preserve the prevailing				
18	neighborhood character of the Calle 24 Latino Cultural District while accommodating new uses and				
19	recognizing the contributions of the Latino community to the neighborhood and San Francisco.				
20	Realizing the purpose of the Calle 24 Special Use District will require the participation and				
21	coordination of residents, businesses, public agencies, and other community stakeholders. City				

agencies, including the Office of Economic and Workforce Development, will actively engage with new

commercial uses to help achieve the purposes of the Calle 24 Special Use District. Such City agencies

may act as resource for residents, businesses, and other community stakeholders when realizing and

2	partnerships, product offerings, and employment commitments.		
3	Specifically, the Calle 24 Special Use District is established to:		
4	(1) Preserve and enhance the unique character of the Calle 24 Special Use District		
5	and recognize Latino cultural heritage through contextual architectural design, storefront size,		
6	signage, streetscape enhancements, artwork, and other elements of the built environment;		
7	(2) Support the production or offerings of local or Latino artwork, arts activities,		
8	and crafts by retaining, developing, promoting, or offering these within the Calle 24 Special Use		
9	<u>District;</u>		
10	(3) Preserve the contributions of Legacy Businesses to the history and identity of the		
11	Special Use District and the Calle 24 Latino Cultural District by preserving a Legacy Business;		
12	(4) Retain, enhance and promote neighborhood serving businesses and institutions		
13	that serve a variety of households by making services and products available and accessible to		
14	residents, including immigrant and low-income and moderate-income households;		
15	(5) Retain, enhance, and promote neighborhood-serving businesses and institutions		
16	that strengthen economic opportunities for local residents by developing partnerships amongst existing		
17	and new local businesses, institutions, vendors, and micro entrepreneurs; and		
18	(6) Retain, enhance and promote neighborhood-serving businesses and institutions		
19	that enhance economic and workforce opportunities for local residents by coordinating with the Office		
20	of Economic and Workforce Development to engage with the City's workforce system to provide		
21	employment opportunities, career trainings, and formal partnerships to identify and address both		
22	business and community workforce needs.		
23	(c) Definitions. Whenever used in this Section 249.59, the following words and phrases		
24	shall have the definitions provided here:		
25			

1	"Calle 24 Latino Cultural District" shall refer to that area as established by Board of
2	Supervisors Resolution No. 201-14;
3	"Cultural Heritage" shall refer to those elements, both tangible and intangible, that
4	help define the beliefs, customs and practices of a particular community. Tangible elements may
5	include land, buildings, public spaces, or artwork. Intangible elements may include organizations and
6	institutions, businesses, and cultural activities and events. These elements are rooted in the
7	community's history and are important in maintaining its identity.
8	"Legacy Business" shall refer to a business as defined under the Administrative Code
9	Section 2A.242 and included in the Legacy Business Registry.
10	(d) Controls. The following provisions, in addition to all other applicable provisions of the
11	Planning Code, shall apply within the Calle 24 Special Use District:
12	(1) Eating and Drinking Establishments. In addition to other prohibitions on such
13	uses found within this Code, a new Restaurant use, new Limited-Restaurant use, new Bar use, or the
14	physical expansion of any such existing use shall be prohibited where the concentration of those uses
15	exceeds, or would exceed with the proposed use or physical expansion of an existing use, 35% of the
16	total commercial frontage as measured in linear feet within the immediate area of the subject site. For
17	the purpose of calculating the concentration of commercial frontage, the "immediate area" shall mean
18	all properties located within 300 feet of the subject property within the Calle 24 Special Use District
19	and in a zoning district that is not Residential or Public Use. Any project for which a development
20	application, as defined in Section 401, was submitted by March 31, 2017 or any change in use from
21	an existing Limited-Restaurant use to a Restaurant use shall be exempt from the requirements of
22	this Section 249.59(d)(1).
23	(2) Conditional Use Authorization. The following, if not otherwise prohibited, shall
24	require Conditional Use authorization from the Planning Commission pursuant to Section 303:

1		<u>(A)</u>	First Story Commercial Use Space Mergers. Any merger of first story		
2	commercial use space where the merger would result in first story commercial use space greater than				
3	799 gross square	<u>e feet.</u>			
4		<u>(B)</u>	Legacy Business. Any new non-residential use where the immediately		
5	prior use was a l	Legacy Bus	iness. This requirement shall not apply:		
6			(i) where the subject non-residential space has had no occupant and has		
7	not been open to	the public	for three or more years from the date the application for the new use is		
8	<u>filed; or</u>				
9			(ii) where the Legacy Business has removed itself or otherwise been		
10	removed from the	e Legacy B	usiness Registry.		
11		<u>(C)</u>	First Story Medical Service Use as defined in Section 790.114.		
12	<u>(3</u>) Comp	patibility of Uses. For any commercial use that is subject to Conditional		
13	Use authorizatio	n under thi	s Section 249.59 or any other section of the Planning Code, the Planning		
14	Commission sha	ll make the	following additional findings:		
15		<u>(A)</u>	Any physical improvements associated with the proposed use are, on		
16	balance, in confo	ormity with	any Calle 24 Design Guidelines adopted by the Planning Commission; and		
17		<u>(B)</u>	The use supports at least four of the purposes for establishing the Calle		
18	24 Special Distri	ict set forth	in Section 249.59(b) above.		
19	Section	3. The Pla	anning Code is hereby amended by revising Sectional Maps SU07		
20	and SU08 of th	e Zoning N	Maps of the City and County of San Francisco as follows:		
21	The Call	e 24 Spec	ial Use District ("Calle 24 SUD") is bounded by the following streets:		
22	(a) To	o the north	n, all lots fronting the southern side of 22nd Street from Mission		
23	Street to Potrer	o Avenue;			
24	(b) T	o the east,	all lots fronting the western side of Potrero Avenue from 22nd Street		
25	to Cesar Chave	ez Street;			

1		(c)	To the south, all lots fronting the northern side of Cesar Chavez Street, from					
2	Potrero Avenue to Capp Street;							
3		(d)	To the west, all lots fronting the western side of Capp Street from Cesar Chavez					
4	to 24th	n Stree	eet, then all lots fronting both sides of 24th Street to the eastern side of Bartlett					
5	Street	Street, then all lots fronting the western side of Capp Street from 24th Street to 22nd Street;						
6	and							
7		(e)	The Calle 24 SUD additionally includes the following lots adjacent to the above					
8	boundaries: Lots 019D and 046A in Assessor's Block 3637; Lots 005 and 017A in Assessor's							
9	Block 6517; Lot 035 in Assessor's Block 6528; and Lot 003A in Assessor's Block 6570.							
10	Section 4. No less than five years and no more than six years from the effective date							
11	of this ordinance, the Office of Economic and Workforce Development and the Planning							
12	Department shall review Planning Code Section 249.59 and shall make a report to the Board							
13	of Supervisors on that section's effectiveness in serving the purposes of the Calle 24 Special							
14	Use District as set forth therein, which report may include recommendations for including							
15	suggesting any recommended amendments.							
16	Section 5. Effective Date. This ordinance shall become effective 30 days after							
17	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the							
18	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board							
19	of Supervisors overrides the Mayor's veto of the ordinance.
