



### Record Breaking Passenger Traffic Growth




- One of the fastest growing airports nationwide.
- Record 25.6 million enplanements or 51.4 million total passengers in FY 15/16.
  - $\sim$  7% increase over prior year; 56% increase since FY 06/07
- Projected 26.8 million enplanements or 53.6 million total passengers in FY 16.17.

- OT budget 1.5% of total salaries
  - Mostly emergency maintenance work and shift coverage for Communications Dispatch and Airfield Operations.
- SFO OT Policy: Employees capped at 16% of their regularly scheduled time and cannot exceed 65 hrs/week.
  - More conservative than City Policy of 25% of regular schedule and 72hrs/per week.









## Local Cost Per Enplanement (CPE) Comparison

#### Estimated FY 2017/18 CPE Bay Area Airports



- Overall CPE is higher than SJC and OAK because SFO has more costly long haul international flights.
- Average airfares from SFO to major short and medium haul markets are competitive relative to these airports.
- SFO dominates long haul and international traffic in the Bay Area as an international gateway and connecting hub.

SFO operates a wide variety of internship and job training programs, including programs that target at risk youth.

- FY 15/16: 133 interns
- FY 16/17: 127 interns to date,153 anticipated by year-end (24% increase over prior year)

SFO also connects airlines and SFO concessionaires with SF residents and local community members via its Office of Employment & Community Partnerships & SFO First Source Initiative.

- $\blacksquare$  FY 15/16 worked with 100 tenants and served 3,500+ job seekers
- FY 15/16 hires: 653
- FY 16/17 worked with 190 tenants and served 3,583 job seekers YTD
- FY 16/17 hires: 1,012 YTD


## Social Responsibility & Community Sustainability

#### FY 15/16 Concessions

- 75% of concession leases and 35% of retail leases had owners headquartered in San Francisco and the Bay Area
- 63% of food and retail sales (\$22 million) earned by San Francisco/Bay Area owners

#### FY 16/17 Concessions YTD

- 65% of concession and retail leases had owners headquartered in San Francisco and the Bay Area
- 70% of food and retail sales (\$19 million) earned by San Francisco/Bay Area owners
- New program to ensure SFO reflects the iconic nature of San Francisco's historic restaurant scene and the cultural diversity of San Francisco cuisine



## **Upcoming Initiatives**

#### Noise Abatement

- Long history of proactively addressing noise levels within our community
  - Established nation's first airport/community round table
  - Outfitted more than 15,000 homes with residential sound abatement retrofits
- Continue to lean in on the aircraft noise issue
  - Successfully lobbied United and Virgin America to install noise reducing equipment on aircraft
  - Pursuing a new GPS landing system with noise reduction opportunities
  - Maintaining close dialogue with FAA on community concerns with FAA's new flight patterns

#### Airport Development Plan (ADP)

Roadmap for accommodating up to 71.1 million annual passengers, our current airfield capacity.

#### **Duty Free Lease Renewal**

 $\blacksquare$  MAG will increase rental revenues by \$13 million annually over FY 15/16 actuals
