[Settlement of Lawsuit - Satinder Singh - \$425,000]

Ordinance authorizing settlement of the lawsuit filed by Satinder Singh against the City and County of San Francisco for \$425,000; the lawsuit was filed on January 23, 2014, in San Francisco Superior Court, Case No. CGC-14-536941; entitled Satinder Singh v. Xuong Lu, et al.; the lawsuit involves alleged personal injury from a vehicle collision.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Satinder Singh v. Xuong Lu, et al.</u>, San Francisco Superior Court, Case No. CGC-14-536941 by the payment of \$425,000. The lawsuit involves alleged personal injury from a vehicle collision.
