Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

- (a) The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 190248 and is incorporated herein by reference. The Board affirms this determination.
- (b) On May 9, 2019, the Planning Commission, in Resolution No. 20450, adopted findings that the actions contemplated in this ordinance are consistent, on balance, with the City's General Plan and eight priority policies of Planning Code Section 101.1. The Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. 190248, and is incorporated herein by reference.
- (c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that these Planning Code amendments will serve the public necessity, convenience, and general welfare for the reasons set forth in Planning Commission Resolution No. 20450.

Section 2. The Planning Code is hereby amended by revising Sections 102, <del>145.4,</del> 202.2, 303, <u>710, 718, 721, 752, 754, 757, 759, 760,</u> and 764, to read as follows: **SEC. 102. DEFINITIONS.**

Institutional Community Use. A subcategory of Institutional Uses that includes Child Care
Facility, Community Facility, Private Community Facility, Job Training, Philanthropic
Administrative Services, Religious Institution, Social Service or Philanthropic Facility, and
Public Facility.

**Liquor Store.** A Retail Sales and Service Use that sells beer, wine, or distilled spirits to a customer in an open or closed container for consumption off the premises and that needs a State of California Alcoholic Beverage Control Board License type 20 (off-sale beer and wine) or type 21 (off-sale general). This classification shall not include retail uses that:

\* \* \* \*

(c) For purposes of Planning Code Sections 249.5, 781.8, 781.9, 782, and 784, the retail uses explicitly exempted from this definition as set forth above shall only apply to General Grocery and Specialty Grocery stores that exceed 5,000 square feet in size <u>and</u> shall not:

(3) sell single servings of beer in container sizes 24 ounces or smaller.

Liquor Store uses are subject to the operating conditions of Section 202.2(a)(6). Where conditionally permitted, the Conditional Use authorization shall also satisfy the conditions of Section 303(z).

**Open Air Sales.** A Commercial Use Characteristic generally categorized as a Retail Sales and Service Use that involves open air sale of new and/or used merchandise, except vehicles, but including agricultural products, *plants and gardening supplies, building materials*, crafts, and/or art work.

Service, Philanthropic Administrative. An Institutional Community Use that provides executive, management, administrative, and clerical services and support related to

philanthropic activities that serve non-profit institutions and organizations; such philanthropic activities may include funding and support of educational, medical, environmental, cultural, and social services institutions and organizations. Such Uses:

- (a) may not be located on the First Story of buildings where the most recent prior Use was any Use other than Residential or Office; and
- (b) may be located in a single undivided space not physically separated from a Residential Use; provided that any Residential Conversion above the First Story, associated with, or following commencement of such Use, shall be considered a Conditional Use requiring approval pursuant to Section 317.

#### SEC. 202.2. LOCATION AND OPERATING CONDITIONS.

- (a) **Retail Sales and Service Uses.** The Retail Sales and Service Uses listed below shall be subject to the corresponding conditions:
- (6) Liquor Stores. Liquor Stores, as defined in Section 102, shall comply with the following requirements:
- the premises sometime between 30 minutes after closing time and 8:00 a.m. the following morning, and shall pick up and dispose of any discarded beverage containers and other trash left by patrons. The business operator shall maintain the main entrance to the building and all sidewalks abutting the subject property in a clean and sanitary condition in compliance with the Department of Public Works Streets and Sidewalk Maintenance Standards, maintained by the Department's Bureau of Street Use and Mapping. In addition, the business operator shall be responsible for daily monitoring of the sidewalk within a one-block radius of the subject

lower floors and housing above. These districts are well-served by public transit and aim to maximize residential and commercial opportunities on or near major transit services. The district's form can be either linear along transit-priority corridors, concentric around transit stations, or broader areas where transit services criss-cross the neighborhood. Housing density is limited not by lot area, but by the regulations on the built envelope of buildings, including height, bulk, setbacks, and lot coverage, and standards for Residential Uses, including open space and exposure, and urban design guidelines. Residential parking is not required and generally limited. Commercial establishments are discouraged or prohibited from building accessory off-street parking in order to preserve the pedestrian-oriented character of the district and prevent attracting auto traffic. There are prohibitions on access (i.e. driveways, garage entries) to off-street parking and loading on critical stretches of NC and transit streets to preserve and enhance the pedestrian-oriented character and transit function.

- NCT-3 Districts are intended in most cases to offer a wide variety of comparison and specialty goods and services to a population greater than the immediate neighborhood, additionally providing convenience goods and services to the surrounding neighborhoods. NCT-3 Districts include some of the longest linear commercial streets in the City, some of which have continuous retail development for many blocks. Large-scale lots and buildings and wide streets distinguish the districts from smaller-scaled commercial streets, although the districts may include small as well as moderately scaled lots. Buildings may range in height, with height limits varying from four to eight stories.
- $\underline{(c)}$  NCT-3 building standards permit moderately large  $e\underline{C}$  ommercial  $\underline{u}\underline{U}$  ses and buildings. Rear yards are protected at residential levels.
- (d) A diversified commercial environment is encouraged for the NCT-3 District, and a wide variety of uses are permitted with special emphasis on neighborhood-serving businesses. Eating and *dD*rinking, *eE*ntertainment, and financial service uses generally are

permitted with certain limitations at the first and second stories. Auto-oriented uses are somewhat restricted. Other retail businesses, personal services and offices are permitted at all stories of new buildings. Limited storage and administrative service activities are permitted with some restrictions.

Housing development in new buildings is encouraged above the second story. Existing rResidential uUnits are protected by limitations on demolitions and upper-story conversions. Accessory Dwelling Units are permitted within the district pursuant to subsection 207(c)(4) and 207(c)(6) of this Code.

### SEC. 764. UPPER MARKET STREET NEIGHBORHOOD COMMERCIAL TRANSIT DISTRICT.

The Upper Market Street Neighborhood Commercial Transit District is located on Market Street from Church to Noe Streets, and on side streets off Market. Upper Market Street is a multi-purpose commercial district that provides <code>limited convenience goods and services</code> to adjacent neighborhoods, but also serves as a shopping street for a broader trade area. <code>A large number of offices are located on Market Street within easy transit access to downtown.</code> The width of Market Street and its use as a major arterial diminish the perception of the Upper Market Street Transit District as a single commercial district. The street appears as a collection of dispersed centers of commercial activity, concentrated at the intersections of Market Street with secondary streets.

\* \* \* \*

The Upper Market Street  $\underline{Transit}$   $d\underline{D}$  istrict controls are designed to promote moderate-scale development which contributes to the definition of Market Street's design and character. They are also intended to preserve the existing mix of  $e\underline{C}$  ommercial  $\underline{u}\underline{U}$  ses and maintain the livability of the district and its surrounding residential areas. Large-lot and use development is reviewed for consistency with existing development patterns. Rear yards are protected at all levels. To promote mixed-use buildings, most  $e\underline{C}$  ommercial  $\underline{u}\underline{U}$  ses are permitted with some limitations above the second story. In order to maintain continuous retail frontage and preserve a balanced mix of  $e\underline{C}$  ommercial  $\underline{u}\underline{U}$  ses, ground-story neighborhood-serving uses are encouraged, and  $e\underline{E}$  ating and  $d\underline{D}$  rinking,  $e\underline{E}$  intertainment, and financial service uses are limited. Ground floor-commercial space is required along Market and Church Streets. Should a Restaurant fail to operate as a Bona Fide Eating Place for any length of time, the  $\underline{eC}$  onditional  $\underline{uU}$ se authorization  $\underline{for\ the\ Bar\ use}$  shall be subject to immediate revocation.

(7) Clinics licensed as community and free clinics as defined under California Health and Safety Code Section 1204(a)(1) and clinics exempt from licensing under California Health and Safety Code Section 1206(b) are Principally Permitted Uses. Other Health Service uses are subject to the provisions of Section 303.1 of this Code. Within the Upper Market Street Neighborhood Commercial Transit District, an existing Bar on the ground floor operating

under a Conditional Use authorization may expand to the second floor if: (a) the space to be converted has not been in Residential use within the previous five years, (b) an internal staircase connecting the ground floor Bar use and the upper floor already exists, and (c) there will be no expansion of the building envelope.

- (8) Within the Upper Market Neighborhood Commercial Transit District, up to four mechanical amusement devices are considered an accessory use and up to ten mechanical amusement devices will be considered an Amusement Game Arcade use.
- (8) Arts Activities and Institutional Community Uses in the Upper Market Street NCT District are considered to be "active uses," as defined in Section 145.4 of this Code.

Section 3. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.

Section 5. Amendment of Specific Zoning Control Tables. Zoning Control Tables 711.

712, 713, 714, 715, 716, 717, 719, 720, 722, 723, 724, 725, 728, 729, 730, 731, 732, 733,

734, 750, 751, 753, 755, 756, 761, 762, and 763 are hereby amended identically to the amendment of Zoning Control Table 710 in Section 2 of this ordinance, to delete Philanthropic Admin. Services from the list of Institutional Uses in the "Controls by Story" section.

Section 6. At its regular meeting on July 8, 2019, the Board of Supervisors Land Use and Transportation Committee amended Planning Code Section 145.4. At its subsequent meeting on July 15, 2019, the Committee removed that amendment from this ordinance, so the text of Section 145.4 no longer appears in the ordinance.

Ordinance amending the Planning Code to revise the NCT-3 (Moderate-Scale Neighborhood Commercial Transit) District controls to allow Arts Activities, Philanthropic Administrative Services, and Public Facilities as a principal use on all stories and provide that in this District Arts Activities are considered to be active uses; revise the Upper Market Neighborhood Commercial Transit (NCT) District controls to allow Arts Activities and Institutional Uses as a principal use on all the first and second stories, allow Institutional Uses as a principal use on the first and second stories and as a conditional use on the third story and above, and to allow General Entertainment as a principal use on the first and second stories, delete the note for an existing ground-floor bar, and require a health service use on the first story that is not a licensed community or free clinic to comply with formula retail controls; delete the Upper Market NCT District from the requirements for ground floor commercial uses; modify the requirements for liquor stores and bars in the NCT-3 and Upper Market Street NCT Districts, add additional conditional use criteria for liquor stores and require liquor stores to comply with standard location and operating conditions, and add additional uses to the definition of Open Air Sales; delete Philanthropic Administrative Services from the Code as a separately-defined Institutional Use; affirming the Planning Department's determination under the California Environmental Quality Act; making findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1; and adopting findings of public necessity, convenience, and general welfare under Planning Code, Section 302.
