Ordinance authorizing settlement of the lawsuit filed by Joan Frost against the City and County of San Francisco for \$105,000; the lawsuit was filed on August 3, 2018, in San Francisco Superior Court, Case No. CGC-18-568679; entitled <u>Joan Frost v. The City and County of San Francisco, et al.</u>; the lawsuit involves alleged personal injury from a motor vehicle collision; and appropriating \$105,000 from the San Francisco Public Utilities Commission Wastewater Enterprise fund balance for payment of settlement.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Joan Frost v. The City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC-18-568679 by the payment of \$105,000. The lawsuit involves alleged personal injury from a motor vehicle collision.
