ISupporting the Mayor's Consent to Continue Refugee Resettlement in the Cityl

Resolution supporting the resettlement of refugees within the City and concurring in the Mayor's consent to accept refugees in the City under the United States Department of State's Reception and Replacement Program.

WHEREAS, The City has a long history of accepting immigrants and refugees from around the world and has implemented policies to help them thrive and feel safe, such as the Sanctuary City Ordinance, Chapter 12H of the Administrative Code; and

WHEREAS, Refugees, by definition, are people outside the country of their nationality and unable or unwilling to return to that country due to a well-founded fear of persecution because of their race, religion, nationality, membership in a particular social group, or political opinion; and

WHEREAS, Resettlement is a humanitarian protection tool developed by the United States and other countries as a last resort for refugees who cannot return to their home country and cannot rebuild their lives in the country to which they first fled; and

WHEREAS, The U.S. State Department's Reception and Resettlement Program provides placement and assistance to refugees for the first few months after they have been accepted for resettlement in the United States, and the U.S. Department of Health and Human Services provides assistance thereafter; and

WHEREAS, President Donald Trump reduced the annual cap on refugee admittance from 110,000 in fiscal year 2017, to 30,000 in 2019, to just 18,000 in 2020, a historic low, while according to the United Nations High Commissioner for Refugees the number of refugees worldwide approximately doubled between 2012 and 2018 to more than 20,000,000; and

WHEREAS, On September 26, 2019, President Trump signed Executive Order 13888 entitled "Enhancing State and Local Involvement in Refugee Resettlement" (the "Executive Order"), which purports to require state and local governments to consent to receive refugees under the Reception and Placement Program before the federal government will resettle refugees within such jurisdictions; and

WHEREAS, The Executive Order likely violates the federal Refugee Act, and refugee resettlement organizations have sued to block the Executive Order; and

WHEREAS, The Executive Order does not comport with the goal of the refugee and resettlement system, because it reduces the possible resettlement options available for this vulnerable population of individuals who have already suffered extensively after being forced from their countries of origin; and

WHEREAS, Consistent with the Sanctuary City Ordinance and other City policy, Mayor London N. Breed sent a letter to Secretary of State Michael Pompeo, affirming the City's consent under the Executive Order to continue receiving refugees, a copy which is available in Board File No. 191301; and

WHEREAS, San Francisco values refugees and immigrants of all types for their resilience, hard work ethic, and their significant contributions to the City's diverse and vibrant communities and the local economy; and

WHEREAS, Without accepting the validity of the Executive Order, it is important for the City to affirm its commitment to welcoming refugees and its opposition to President Trump's drastic cuts in the number of refugees admitted to the United States; now, therefore, be it

RESOLVED, That the City supports a robust refugee resettlement system in the United States and opposes actions by President Trump to slash the number of refugees accepted by the United States and his efforts to undermine the efficacy of the program; and, be it

FURTHER RESOLVED, That the Board of Supervisors concurs with the Mayor's consent under the Executive Order to continue receiving refugees in San Francisco; and, be it

FURTHER RESOLVED, That in such concurrence, the City does not concede that the Executive Order complies with federal law, nor does it place a lawful condition on the placement of refugees.

Dear Secretary Pompeo,

This letter is in reference to Executive Order 13888, "On Enhancing State and Local Involvement in Resettlement."

I write to affirm that San Francisco consents to the resettlement of refugees within San Francisco under the Department of State's Reception and Placement Program. To alleviate the need for any subsequent consent to be given, this consent is given until revoked.

San Francisco nonetheless contends that Executive Order 13888 violates federal law, and by providing consent San Francisco does not concede that the Executive Order places a lawful condition on the placement of refugees. Refugee resettlement organizations have sued to block the Executive Order. The Executive Order not only violates the law, it undermines the goal of ensuring refugees have the best chance at succeeding in this country by limiting the places available for them to be resettled. The Executive Order stands against the values of acceptance and inclusivity upon which our country was founded.
