3 **Resolution authorizing the Department of the Environment (SF Environment) to**  
4 **retroactively accept and expend funds from the United States Department of Energy's**  
5 **Office of Energy Efficiency and Renewable Energy Vehicle Technologies Program**  
6 **(being passed through Research and Development Solutions, LLC) in the amount of**  
7 **\$60,000 to support San Francisco's Clean Cities Coalition Program and its work related**  
8 **to reducing petroleum use and improving air quality in the City and County of San**  
9 **Francisco.**

10 WHEREAS, the United States Department of Energy's Office of Energy Efficiency and  
11 Renewable Energy Vehicle Technologies Clean Cities Coalition Program has approved the  
12 appointment of SF Environment's Clean Vehicles Program Manager to the position of San  
13 Francisco Clean Cities Coordinator; and

14 WHEREAS, The U.S. Department of Energy's Office of Energy Efficiency and  
15 Renewable Energy Vehicle Technologies provides annual supplemental funding (passed  
16 through Research and Development Solutions, LLC) to cover activities of the San Francisco  
17 Clean Cities Coalition Coordinator; and

18 WHEREAS, The goals and objectives of U.S. Department of Energy's Clean Cities  
19 Coalition Program are aligned with the goals and objectives of the City and County of San  
20 Francisco related to improving air quality, reducing petroleum usage and reducing global  
21 warming emissions; and

22 WHEREAS, Funds from the U.S. Department of Energy's Clean Cities Coalition  
23 Program support the Clean Air Program's ongoing efforts to implement the City's  
24 Environmental Codes related to air quality and emissions reductions; and


1 WHEREAS, These efforts include activities such as promoting alternative fuel vehicles,  
2 facilitating the use of alternative fuels to displace petroleum, and providing outreach and  
3 education to local fleet operators; and

4 WHEREAS, the grant budget includes provision for indirect costs of \$5,455; and

5 WHEREAS, this grant does not require an ASO amendment; now, therefore, be it

6 RESOLVED, that the Board of Supervisors hereby authorizes the Director of the  
7 Department of the Environment to retroactively accept and expend \$60,000 from the US  
8 Department of Energy's Office of Energy Efficiency and Renewable Energy Vehicle  
9 Technologies Clean Cities Coalition Program (being passed through Research and  
10 Development Solutions, LLC) to perform work related to improving air quality, reducing  
11 petroleum usage and reducing global warming emissions in the City and County of San  
12 Francisco.


