Ordinance authorizing settlement of the lawsuit filed by Lester Hogan against the City and County of San Francisco for \$50,000; the lawsuit was filed on February 18, 2021, in United States District Court, Northern District of California, Case No. 22-cv-6112-DMR (NMC); entitled Lester Hogan v. Deputy Ibarra; the lawsuit involves alleged civil rights violations; the City already paid \$25,000 to Plaintiff, and the City will pay \$25,000 to Kaiser Foundation Health Plan, Inc. (via the Rawlings Company) to satisfy a Medicare Advantage lien for Plaintiff's medical treatment relating to the incident.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Lester Hogan v. Deputy Ibarra, U.S. District Court, Northern District of California, Case No. 22-cv-6112-DMR (NMC) by the payment of \$50,000, \$25,000 of which the City has already paid to Plaintiff, and \$25,000 of which the City will pay to Kaiser Foundation Health Plan, Inc. (via the Rawlings Company) to satisfy a Medicare Advantage lien for Plaintiff's medical treatment relating to the incident. The lawsuit involves alleged civil rights violations.

Section 2. The above-named action was filed in U.S. District Court, Northern District of California on February 18, 2021, and the following parties were named in the lawsuit: Plaintiff Lester Hogan; Defendant Deputy Fernando Ibarra.
