1 [Building, Green Building, Mechanical, and Plumbing Codes - Amending Findings Supporting
2 Enactment of 2022 Codes]

3 **Ordinance amending the local findings included by reference in the following**
4 **Ordinances: 1) 2022 San Francisco Building Code (Ordinance No. 225-22); 2) 2022 San**
5 **Francisco Green Building Code (Ordinance No. 227-22); 3) 2022 San Francisco**
6 **Mechanical Code (Ordinance No. 228-22); 4) San Francisco Plumbing Code (Ordinance**
7 **No. 230-22); and directing the Clerk of the Board to forward the Ordinance to the**
8 **California Building Standards Commission as required by State law.**

16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Environmental Findings. The Planning Department has determined that the
18 actions contemplated in this ordinance comply with the California Environmental Quality Act
19 (California Public Resources Code Sections 21000 et seq.). Said determination is on file with
20 the Clerk of the Board of Supervisors in File No. 231125 and is incorporated herein by
21 reference. The Board affirms this determination.

22 Section 2. General Findings.

23 (a) The California Building Standards Code is contained in Title 24 of the California
24 Code of Regulations. It consists of 12 Parts, which are based upon model codes that are
25 amended by the State agencies with jurisdiction over the subject matter. The State of

1 California adopts a new California Building Standards Code every three years (“triennial
2 CBSC”) with supplemental amendments published in intervening years. Local jurisdictions
3 must enforce the California Building Standards Code but they may also enact more restrictive
4 building standards that are reasonably necessary because of local climate, geologic, or
5 topographical conditions. Local amendments may be made both to a triennial CBSC and also
6 to its individual Parts during the intervening years; however, local amendments previously
7 adopted are not automatically applicable to a triennial CBSC. Rather, they must be re-enacted
8 with the required findings of local climate, geologic, or topographical conditions, expressly
9 made applicable to the new triennial CBSC, and with an operative date no earlier than the
10 effective date of the new State Code.

11 (d) Consistent with the triennial CBSC, the Board of Supervisors: repealed the 2019
12 San Francisco Building and enacted the 2022 San Francisco Building Code by the enactment
13 of Ordinance Number 225-22, in Board File No. 220940; repealed the 2019 San Francisco
14 Green Building Code and enacted the 2022 San Francisco Green Building Code by the
15 enactment of Ordinance Number 227-22, in Board File No. 220942; repealed the 2019 San
16 Francisco Mechanical Code and enacted the 2022 San Francisco Mechanical Code by the
17 enactment of Ordinance Number 228-22, in Board File No. 220943; and repealed the 2019
18 San Francisco Plumbing Code and enacted the 2022 San Francisco Plumbing Code by the
19 enactment of Ordinance Number 230-22, in Board File No. 220945 (hereinafter, collectively,
20 “2022 Building Code Ordinances”).

21 (e) Pursuant to California Health and Safety Code Sections 17958.7 and 18941.5,
22 the Board of Supervisors made express findings, section-by-section, that each local
23 amendment to the California Building Standards Codes was reasonably necessary because of
24 local conditions. The findings are contained in Exhibit A to each of the 2022 Building Code
25 Ordinances, and are on file with the Clerk of the Board in the respective Board Files.

1 (f) Upon enactment of the 2022 Building Code Ordinances, the Clerk of the Board
2 of Supervisors forwarded the ordinances to the California Building Standards Commission.
3 The California Building Standards discovered technical omissions in Exhibit A to these 2022
4 Building Code Ordinances and requested correction to the respective files. This Ordinance
5 makes the technical corrections requested by the California Building Standards Commission
6 by updating the local findings incorporated by reference in each of the Building Code
7 Ordinances.

8 (g) On October 18, 2023, at a duly noticed public hearing, the Building Inspection
9 Commission considered this ordinance in accordance with Charter Section D3.750-5 and
10 Building Code Section 104A.2.11.1.1. A copy of a letter from the Secretary of the Building
11 Inspection Commission regarding the Commission's recommendation is on file with the Clerk
12 of the Board of Supervisors in File No. 231125.

13
14 Section 3. Findings Regarding Local Conditions. Pursuant to California Health and
15 Safety Code Sections 17958.7 and 18941.5, the Board of Supervisors finds and determines
16 that the local conditions described in: Corrected Exhibit A to the 2022 San Francisco Building
17 Code; Corrected Exhibit A to the 2022 San Francisco Green Building Code; Corrected Exhibit
18 A to the 2022 San Francisco Mechanical Code; and Corrected Exhibit A to the 2022 San
19 Francisco Plumbing Code constitute a general summary of the most significant local
20 conditions giving rise to the need for modification of the respective 2022 California Building
21 Standards Codes and are reasonably necessary based upon these local conditions. Each
22 Corrected Exhibit A is on file with the Clerk of the Board of Supervisors in Board File
23 No. 231125.

1 Section 4. The 2022 San Francisco Building Code Ordinances are amended as
2 follows:

3 (a) Ordinance Number 225-22, File No. 220940 is amended by replacing Exhibit A
4 with the Corrected Exhibit A to the 2022 San Francisco Building Code in Board File
5 No. 231125. The corrections are tracked in italicized and underlined type and deletions are in
6 ~~strikeout~~ text.

7 (b) Ordinance Number 227-22, File No. 220942 is amended by replacing Exhibit A
8 with the Corrected Exhibit A to the 2022 San Francisco Green Building Code in Board File
9 No. 231125. The corrections are tracked in italicized and underlined type and deletions are in
10 ~~strikeout~~ text.

11 (c) Ordinance Number 228-22, File No. 220943 is amended by replacing Exhibit A
12 with the Corrected Exhibit A to the 2022 San Francisco Mechanical Code in Board File
13 No. 231125. The corrections are tracked in italicized and underlined type and deletions are in
14 ~~strikeout~~ text.

15 (d) Ordinance Number 230-22, File No. 220945 is amended by replacing Exhibit A
16 with the Corrected Exhibit A to the 2022 San Francisco Plumbing Code in Board File
17 No. 231125. The corrections are tracked in italicized and underlined type and deletions are in
18 ~~strikeout~~ text.

LEGISLATIVE DIGEST

[Building, Green Building, Mechanical, and Plumbing Codes - Amending Findings Supporting Enactment of 2022 Codes]

Ordinance amending the local findings included by reference in the following Ordinances: 1) 2022 San Francisco Building Code (Ordinance No. 225-22); 2) 2022 San Francisco Green Building Code (Ordinance No. 227-22); 3) 2022 San Francisco Mechanical Code (Ordinance No. 228-22); 4) San Francisco Plumbing Code (Ordinance No. 230-22); and directing the Clerk of the Board to forward the Ordinance to the California Building Standards Commission as required by State law.

Existing Law

The 2022 San Francisco Building Inspection Codes (“2022 Building Codes”) regulate and control the design, construction, quality of materials, use and occupancy, location, maintenance and demolition of all buildings and structures. The 2022 Building Codes are based on the 2022 California Building Codes and local amendments that the City finds are reasonably necessary to address local conditions. The legislative files for each 2022 Building Code ordinance include an exhibit listing the applicable findings supporting the local amendments to that Code.

Amendments to Current Law

The supporting exhibits for 2022 Building, Green Building, Mechanical and Plumbing Codes inadvertently omitted findings for several subsections and appendices. The Proposed Legislation corrects these omissions by amending the applicable exhibits for each of the ordinance files.

Ordinance: Technical Edits to the Findings Supporting Local Amendments to the SF Building Codes

Board of Supervisors Land Use & Transportation Committee
December 11, 2023

Background

- Consistent with the triennial California Building Standards Commission (CBSC) code cycle, the Board of Supervisors enacted the 2022 San Francisco Building Codes:
 - 2022 San Francisco Building Code (Ordinance Number 225-22)
 - 2022 San Francisco Green Building Code (Ordinance Number 227-22)
 - 2022 San Francisco Mechanical Code (Ordinance Number 228-22)
 - 2022 San Francisco Plumbing Code (Ordinance Number 230-22)
- The Board of Supervisors made express findings, section-by-section, that each local amendment to the California Building Standards Code was reasonably necessary because of local conditions (generally related to topography, geology and climate).
- The findings are contained in Exhibit A to each of the 2022 Building Code Ordinances, and are on file with the Clerk of the Board in the respective Board files.

EXHIBIT A

STANDARD FINDINGS FOR SAN FRANCISCO BUILDING STANDARDS CODE AMENDMENTS:

1. Certain buildings/occupancies in San Francisco are at increased risk for earthquake-induced failure and consequent fire due to local hazardous micro zones, slide areas, and local liquefaction hazards. (Geology)
2. Certain buildings/occupancies in San Francisco are at increased risk of fire due to high density of buildings on very small lots, with many buildings built up to the property lines. (Topography)
3. Topography of San Francisco has led to development of a high density of buildings on small lots, necessitating special provisions for exiting, fire separation, or fire-resistive construction. (Topography)
4. Many buildings are built on steep hills and narrow streets, requiring special safety consideration. (Topography)
5. Additional fire, structural and other protection is required due to high building density and crowded occupancy. (Topography)
6. San Francisco has narrow, crowded sidewalks due to building and population density and unusual topography. (Topography)
7. All rain water in San Francisco drains to the building drains and sewer; unusual geology, occasional extremely high local rainfall amounts, and the configuration of the City as a peninsula restrict the installation of separate storm water and sewer systems. (Topography, Climate, Geology)
8. Moist, corrosive atmosphere of salt-laden fog in San Francisco necessitates additional requirements. (Climate)
9. Not a building standard; no local findings required.
10. Soil conditions in this region induce adverse reactions with some materials, leading to premature failures and subsequent unsanitary conditions. (Climate)
11. The region is subject to fluctuating rainfall due to changes in climatic conditions. (Climate)
12. San Francisco is a peninsula surrounded on three sides by water at sea level; mitigation of climate change impacts, including sea level rise, is critical to the long term protection of the local built environment and local infrastructure. (Topography)
13. Climate and potential climate change impacts San Francisco's water resources, including reservoirs and distribution facilities. (Climate)
14. Organic material in San Francisco's waste breaks down into methane gas which is a significant contributor to climate change. (Climate)
15. San Francisco is topographically constrained and its built environment occupies most available land, requiring minimization of debris and solid waste. (Topography)
16. Prevailing winds, coastal mountain ranges, and periodic seasonal high temperatures contribute to photochemical reactions that produce smog and ozone; limiting the emission of smog's chemical precursors - volatile organic chemicals and oxides of nitrogen - is necessary to health and safety. (Climate, Topography)
17. The aquifers underlying San Francisco are small relative to local population, necessitating ongoing water imports and special provisions to ensure efficient use of water in local buildings. (Geology)

- The ordinance makes no changes to the underlying Building Codes, only the indexes of findings.

Recommended by Code Advisory Committee and Building Inspection Commission

On October 12, 2023, the Department of Building Inspection's Code Advisory Committee made a unanimous recommendation to the Building Inspection Commission to recommend approval of the ordinance to the Board of Supervisors.

On October 18, 2023, the Building Inspection Commission made a unanimous recommendation of approval of the ordinance to the Board of Supervisors.

Attached please find a proposed ordinance, considered and approved by the Building Inspection Commission on October 18, 2023, amending the local findings included by reference in the following ordinances:

- 1) 2022 San Francisco Building Code (Ordinance Number 225-22; File No. 220940)
