[Approval of Amendment to Design Agreement for the Laguna Honda Hospital Replacement Program]

**Resolution authorizing the Director of Public Works to execute amendment to a design agreement for the Laguna Honda Hospital Replacement Program from \$33,706,892 to \$39,155,175.**

WHEREAS, The Director of Public Works has entered into an agreement dated November 30, 2000 with Anshen+Allen/Gordon H. Chong & Partners, A Joint Venture for the design of the Laguna Honda Hospital Replacement Program in an amount of not to exceed \$2,400,352; and,

WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of ten million dollars or amendments to said agreements in excess of \$500,000 be approved by the Board of Supervisors; and

WHEREAS, Resolutions 994-01, 579-03, 561-04 and 667-05, the Board of Supervisors authorized the Director to enter into amendments to the agreement which when amended would not exceed \$33,706,892; and,

WHEREAS, the Director intends to increase the scope of services under said agreement for additional construction administration services, completion of the Remodel Construction Documents, additional geotechnical services, and services for Converging Technology, Leed Documentation and Assisted Living Feasibility Study and to increase the sum under said agreement to \$39,155,175; now, therefore, be it

RESOLVED, That the Board of Supervisors does hereby authorize the Director of Public Works to enter into amendments to the November 30, 2000 agreement with Anshen+Allen/Gordon H. Chong, A Joint Venture, resulting in a contract amount not to exceed \$39,155,175.




