Ordinance accepting irrevocable offers of public infrastructure associated with the Hunters View HOPE SF Project, Phase 2, including an offer of improvements for infrastructure located within Catalina Street, Fairfax Avenue, Ingalls Street, Innes Avenue, Ironwood Way, and Middle Point Road, and an offer of dedication for real property for portions of Fairfax Avenue, Ironwood Way, and Middle Point Road; dedicating said public improvements for public use; designating said public improvements for public street and roadway purposes; accepting said public infrastructure for City maintenance and liability purposes, subject to specified limitations; establishing official street grades, sidewalk widths, and public right-of-way widths; amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks” to establish official sidewalk widths on Catalina Street, Fairfax Avenue, Ingalls Street, Innes Avenue, Ironwood Way, and Middle Point Road; accepting an offer of dedication for Phase 2 easements; delegating authority to the Public Works Director to accept the Phase 3 public infrastructure, including authority to take all of the Phase 2 actions in this ordinance for Phase 3; authorizing the Director of Property to execute deeds and easement agreements, as specified; accepting a Public Works Order recommending various actions in regard to the public infrastructure improvements; adopting findings under the California Environmental Quality Act; and making findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1.

1 Be it ordained by the People of the City and County of San Francisco:

2
3 Section 1. Background and General Findings.

4 (a) This ordinance addresses the City's acceptance of and other official acts for
5 certain public infrastructure associated with the Hunters View HOPE SF Project, Phases 2
6 and 3 (the "Project"). The Hunters View HOPE SF Project area is generally bounded by
7 Acacia Avenue to the north, Fairfax Avenue to the west and south, and Memory Lane to the
8 south and east. In this ordinance the Board of Supervisors ("Board") accepts, or delegates
9 authority to the Public Works Director to accept, improvements located within portions of
10 Catalina Street, Fairfax Avenue, Ingalls Street, Innes Avenue, Ironwood Way, Memory Lane,
11 and Middle Point Road (collectively, the "Streets").

12 (b) The Project site is owned by the Housing Authority of the City and County of San
13 Francisco ("SFHA"), which is providing various approvals and real estate transfers to facilitate
14 the Hunters View HOPE SF development ("Hunters View HOPE"), including the Project.
15 Hunters View HOPE includes the complete rebuilding of the existing approximately 23-acre
16 Hunters View SFHA site through the City's HOPE SF Program, and will consist of up to 800
17 residential units (approximately 400 affordable and 400 market rate units), community spaces,
18 open space, new streets, utilities, and other infrastructure. Hunters View HOPE has
19 proceeded in three phases.

20 (c) On November 18, 2014, the Board approved Final Map No. 7545 for Phase 2
21 ("Phase 2 Final Map") in Motion No. M14-191, resulting in five buildable lots, one lot for open
22 space, and four lots dedicated to the City as public right-of-way. In the same motion, the
23 Board approved the Phase 2 Public Improvement Agreement between the City and Hunters
24 Point Affordable Housing, Inc. ("Subdivider").
25

1 (d) On July 27, 2021, the Board approved Final Map No. 9677 for Phase 3 ("Phase 3
2 Final Map") in Motion No. M21-122, resulting in seven buildable lots, two lots for open space,
3 and two lots dedicated to the City as public right-of-way. In the same motion, the Board
4 approved the Phase 3 Public Improvement Agreement between the City and Subdivider and
5 conditionally accepted offers of improvements and dedication, subject to completion and
6 further Board action.

7 (e) In conjunction with the Phase 2 and 3 Final Maps, Subdivider irrevocably offered
8 the various public improvements associated with the Project to the City in Offers of
9 Improvements for Phases 2 and 3 (respectively, the "Phase 2 Offer of Improvements" and the
10 "Phase 3 Offer of Improvements," and collectively, the "Offers of Improvements"). The
11 Department of Public Works, in Street Improvement Permit 14IE-0896, dated October 1, 2014
12 ("Phase 2 SIP") and Street Improvement Permit No. 21IE-00193, dated August 11, 2022
13 ("Phase 3 SIP") (collectively, the "Street Improvement Permit"), approved construction of the
14 improvements identified in the Offers of Improvements for acceptance by the City
15 (respectively, the "Phase 2 Public Infrastructure" and "Phase 3 Public Infrastructure," and
16 collectively, the "Public Infrastructure") as well as improvements that will be maintained as
17 private encroachments. Generally, the Public Infrastructure includes street and sidewalk
18 paving, curbs, a portion of the underground utilities, streetlights, and related facilities. The
19 Phase 2 Public Infrastructure does not include the water utility and fire suppression system
20 infrastructure known as the "Westbrook Connection," installed within the area designated as
21 waterline easement ("WLE") on Lot 5 as shown on the Phase 2 Final Map. The Westbrook
22 Connection is not being accepted by this ordinance, as the San Francisco Public Utilities
23 Commission ("SFPUC") and San Francisco Fire Department ("SFFD") have determined it is
24 redundant and unnecessary, and can be eliminated. Copies of the Offers of Improvements
25

1 are on file with the Clerk of the Board in File No. 260710 and incorporated herein by
2 reference.

3 (f) In conjunction with the Phase 2 and 3 Final Maps, SFHA also irrevocably offered
4 for dedication certain easements and certain real property in an Offer of Dedication for each
5 phase (respectively, the "Phase 2 Offer of Dedication" and "Phase 3 Offer of Dedication," and
6 collectively, the "Offers of Dedication"). The Board conditionally accepted the Phase 3 Offer
7 of Dedication in the motion approving the Phase 3 Final Map, subject to completion and
8 further Board action; the Board did not accept the Phase 2 Offer of Dedication in the motion
9 approving the Phase 2 Final Map. A copy of the Offers of Dedication are on file with the Clerk
10 of the Board in File No. 260710 and incorporated herein by reference.

11 (g) The real property offered in fee to the City includes Lots 6, 7, 8, and 9 as shown
12 on the Phase 2 Final Map, and Lots 8 and 9 as shown on the Phase 3 Final Map
13 (respectively, the "Phase 2 Street Parcels" and "Phase 3 Street Parcels," and collectively, the
14 "Street Parcels"). This ordinance approves the acceptance of the Phase 2 Street Parcels and
15 easements offered in conjunction with the Phase 2 Final Map, subject to the exceptions
16 described in subsection (h) below. For Phase 3, subject to the Public Works Director's
17 acceptance of the Phase 3 Public Infrastructure under Section 6 below, this ordinance
18 authorizes the Public Works Director and Director of Property to accept the Phase 3 Street
19 Parcels and easements offered in conjunction with the Phase 3 Final Map.

20 (h) Three of the easements shown on the Phase 2 Final Map are proposed for
21 vacation and will be the subject of trailing legislation submitted to the Board of Supervisors for
22 consideration, specifically, a public access easement, the Westbrook Connection water line
23 easement, and an additional water line easement. The trailing easement vacation legislation
24 is on file with the Clerk of the Board in File No. _____.
25

1 (i) On December 9, 2025, the City Engineer issued a Conditional Notice of
2 Completion, which determined the Phase 2 Public Infrastructure to be complete in accordance
3 with the plans and specifications shown in the Phase 2 SIP, as modified by Instructional
4 Bulletins Nos. 1 through 15, and all City Codes, regulations, and standards governing this
5 infrastructure. The City Engineer determined all conditions listed in the Notice of Completion
6 have been satisfied. In doing so, the City Engineer also certified that the Phase 2 Public
7 Infrastructure is ready for its intended use.

8 (j) Subdivider, its affiliate, or assignee will maintain as encroachments a portion of the
9 infrastructure constructed or installed pursuant to the Phase 2 SIP. The encroachments do
10 not constitute a portion of the Phase 2 Public Improvements, and the City will not accept such
11 encroachments. Such encroachments are to be permitted under a Master Encroachment
12 Permit ("Master Encroachment Permit"), subject to approval of the Board of Supervisors, and
13 will remain the responsibility of Subdivider, its affiliate, or assignee for maintenance and
14 liability.

15 (k) In Public Works Order 300114, dated June 16, 2026 (the "PW Order"), the Public
16 Works Director recommended, with certification from the City Engineer (collectively, the "PW
17 Director"), that the Board approve the legislation to accept the Phase 2 Offer of Dedication for
18 the Phase 2 Street Parcels and easements, and the Phase 2 Offer of Improvements for the
19 Phase 2 Public Infrastructure and dedicate this infrastructure for public use, subject to the
20 exceptions identified below. The PW Director further recommended that the Board approve
21 the ordinance to dedicate the Phase 2 Public Infrastructure for public use, accept it for City
22 maintenance and liability purposes, and in regard to the street areas, designate it as open
23 public right-of-way for permit and roadway purposes, subject to conditions (1) through (5)
24 below. A copy of the PW Order is on file with the Clerk of the Board in File No. 260710 and
25 incorporated herein by reference.

1 (1) The portions of streets being designated as open public right-of-way for
2 street and roadway purposes are from back of sidewalk to back of sidewalk, unless specified
3 otherwise or as shown on the plans and specifications for the Phase 2 Public Infrastructure;

4 (2) Acceptance of the Phase 2 Public Infrastructure for City maintenance and
5 liability purposes is from back of curb to back of curb, unless specified otherwise, and sidewalk
6 maintenance is the responsibility of the adjacent property owners in accordance with the
7 Public Works Code;

8 (3) Encroachments that are or will be permitted (including but not limited to
9 those encroachments to be annexed into the Master Encroachment Permit), not permitted, or
10 both, are excluded from acceptance;

11 (4) The acceptance of the streets does not obviate, amend, alter, or in any way
12 affect existing maintenance agreements between the City and parties to such agreements; and

13 (5) Acceptance of Subdivider's conditional assignment of all warranties and
14 guaranties to the City related to the construction of the Phase 2 Public Infrastructure and its
15 warranty obligations under the Phase 2 SIP.

16 (l) In the PW Order, regarding the Phase 2 Public Infrastructure, the PW Director also
17 recommended the establishment of official public right-of-way widths, sidewalk widths, and
18 street grades on portions of the streets in accordance with Map A-17-248 and Drawing
19 Q-20-1310. Further, the PW Director recommended that the Board amend Ordinance
20 No. 1061 entitled "Regulating the Width of Sidewalks," regarding official sidewalk widths in
21 accordance with Drawing Q-20-1310. Copies of the A Map and Q Drawing are on file with the
22 Clerk of the Board in File No. 260710 and incorporated herein by reference.

23 (m) The Phase 3 Public Infrastructure is substantially completed, but as of the date of
24 this ordinance's introduction, has not been certified as complete by the PW Director. The PW
25 Director anticipates issuing a Notice of Completion for the Phase 3 Public Infrastructure in

1 late 2026. By delegating to the PW Director authority to accept the Phase 3 Public
2 Infrastructure, the Board can consolidate its actions authorizing the Phase 2 and Phase 3
3 Public Infrastructure acceptance into one action, saving both time and financial resources and
4 thus facilitating more effective and efficient Project delivery.

5 (n) In the PW Order, the PW Director recommended that the Board delegate authority
6 to the PW Director, in consultation with applicable City agencies, to approve and accept the
7 Phase 3 Public Infrastructure, including streets, sidewalks, and utilities in the public right-of-
8 way in Memory Lane between Catalina Street and Middle Point Road, and in Fairfax Avenue
9 between Middle Point Road and Memory Lane, once it has been completed to the satisfaction
10 of the PW Director.

11 (o) The PW Director recommended delegating for the Phase 3 Public Infrastructure all
12 of the acceptance actions contained in this ordinance for the Phase 2 Public Infrastructure,
13 including accepting the Phase 3 Offer of Improvement and Phase 3 Offer of Dedication;
14 dedicating the public improvements for public use; designating the public improvements for
15 public street and roadway purposes; accepting the Phase 3 Public Infrastructure for City
16 maintenance and liability purposes; establishing official street grades, sidewalk widths, and
17 public right-of-way widths; and adopting the Planning Department's CEQA, General Plan, and
18 Planning Code Section 101.1 consistency findings.

19 (p) The PW Order also includes a diagram showing the location of the streets that are
20 designated for City acceptance of maintenance and liability in this legislation, or subject to
21 delegated acceptance by the PW Director, encompassing portions of the Streets. The Public
22 Infrastructure includes a combination of new street segments and improvements to previously
23 dedicated public right-of-ways, within Catalina Street, Fairfax Avenue, Ingalls Street, Innes
24 Avenue, Ironwood Way, Memory Lane, and Middle Point Road. The Phase 2 Public
25 Infrastructure is now ready for acceptance for purposes of City maintenance and liability. A

1 copy of the diagram is on file with the Clerk of the Board in File No. 260710 and incorporated
2 herein by reference.

3 (q) The Director of Property, in a letter dated June 12, 2026, recommended that the
4 City accept the grant deeds for the Street Parcels and the easements offered in conjunction
5 with the Phase 2 and 3 Final Maps. A copy of the letter is on file with the Clerk of the Board in
6 File No. 260710 and incorporated herein by reference.

7
8 Section 2. Environmental and Land Use Findings.

9 (a) In a letter dated _____, 2026, the Planning Department determined that
10 the acceptance of the Public Infrastructure, including acceptance of the real property
11 associated with this Public Infrastructure, and associated actions comply with the California
12 Environmental Quality Act (CEQA). For purposes of this ordinance, the Board adopts these
13 findings as its own. A copy of this letter is on file with the Clerk of the Board in File No. _____
14 and incorporated by reference herein.

15 (b) In the same letter, the Planning Department determined that the acceptance of the
16 Public Infrastructure, including acceptance of the real property associated with this Public
17 Infrastructure, and associated actions are, on balance, in conformity with the General Plan
18 and eight priority policies of Planning Code Section 101.1. For purposes of this ordinance, the
19 Board adopts these findings as its own.

20
21 Section 3. Public Works Actions.

22 The Board has reviewed and approves PW Order No. 300114, including the PW
23 Director's recommendations, as referenced in Section 1 of this ordinance, concerning the
24 acceptance of Public Infrastructure, and other actions set forth in the PW Order.

1 Section 4. Acceptance of Phase 2 Public Infrastructure and Assumption of
2 Maintenance and Liability Responsibilities.

3 (a) Pursuant to California Streets and Highways Code Section 1806, San Francisco
4 Administrative Code Sections 1.51 et seq., and PW Order No. 300114, the Board hereby
5 accepts the Phase 2 Offer of Improvements and associated quitclaim deed(s), and dedicates
6 the Phase 2 Public Infrastructure for public use.

7 (b) The Board hereby accepts the Phase 2 Offer of Dedication for Lots 6, 7, 8 and 9 as
8 shown on the Phase 2 Final Map, and their associated grant deeds, and authorizes the
9 Director of Property to execute and record said deeds.

10 (c) The Board hereby accepts the Phase 2 Offer of Dedication for the Emergency
11 Services Access Easement, and its associated easement agreement, and authorizes the
12 Director of Property to execute and record said easement agreement.

13 (d) The Board hereby designates or redesignates the Phase 2 Streets for street and
14 roadway purposes.

15 (e) The Board hereby accepts the Phase 2 Public Infrastructure for City maintenance
16 and liability purposes.

17 (f) The Phase 2 Public Infrastructure accepted and designated pursuant to subsections
18 (a) through (e) of this Section 4 is subject to the following conditions:

19 (1) The portions of Streets being accepted for street and roadway purposes are
20 constructed from back of sidewalk to back of sidewalk, unless specified otherwise or as
21 shown on the permit materials for the Phase 2 Public Infrastructure.

22 (2) Acceptance of the Phase 2 Public Infrastructure for City maintenance and
23 liability purposes is from back of curb to back of curb, unless specified otherwise, and
24 sidewalk maintenance is the responsibility of adjacent property owners or encroachment
25 permittees in accordance with the Public Works Code.

1 (3) Encroachments that are or will be permitted (including but not limited to
2 those that will be permitted under a Master Encroachment Permit), not permitted, or both, are
3 excluded from acceptance.

4 (4) The acceptance of the Phase 2 Public Infrastructure does not obviate,
5 amend, alter, or in any way affect existing maintenance agreements between the City and
6 parties to such agreements.

7 (5) Subdivider's conditional assignment of all warranties and guaranties to the
8 City related to the construction of the Phase 2 Public Infrastructure and their warranty
9 obligations.

10
11 Section 5. Establishment of Public Right-of-Way Widths, Sidewalk Widths, and Street
12 Grades for Phase 2.

13 (a) In accordance with the PW Order, the Board hereby establishes the official public
14 right-of-way widths for portions of Fairfax Avenue, Ironwood Way, and Middle Point Road as
15 set forth in Public Works Map A-17-248.

16 (b) In accordance with the PW Order, Ordinance No. 1061, entitled "Regulating the
17 Width of Sidewalks," a copy of which is in the Clerk of the Board Book of General Ordinances,
18 in effect May 11, 1910, is hereby amended by adding new Section 1652, to read as follows:

19 Section 1652. The width of sidewalks on portions of Catalina Street, Fairfax Avenue, Ingalls
20 Street, Innes Avenue, Ironwood Way, and Middle Point Road shall be modified as shown on the Public
21 Works Drawing Q-20-1310.

22 (c) The sidewalk widths established herein do not obviate, amend, alter, or in any
23 other way affect the maintenance obligations of the adjacent property owners or
24 encroachment permittees as set forth in the Public Works Code.

1 (d) Notwithstanding California Streets and Highways Code Sections 8000 et seq., the
2 Board, in accordance with Administrative Code Sections 1.51 et seq., chooses to follow the
3 City's own procedures for the establishment of street grades. The Board hereby establishes
4 the street grades for portions of Catalina Street, Fairfax Avenue, Ingalls Street, Innes Avenue,
5 Ironwood Way, and Middle Point Road as set forth in Public Works Drawing Q-20-1310.

6 (e) The Board hereby directs Public Works to revise the Official Public Right-of-Way,
7 Sidewalk Width, and Street Grade maps in accordance with this ordinance.

8
9 Section 6. Delegation to Approve and Accept Phase 3 Public Infrastructure.

10 (a) The Board of Supervisors hereby delegates authority to the PW Director, in
11 consultation with applicable City agencies, to approve and accept the finalized Phase 3 Public
12 Infrastructure once it is complete to the satisfaction of the PW Director. The Board of
13 Supervisors hereby delegates its authority under California Streets and Highways Code
14 Section 1806 and San Francisco Administrative Code Sections 1.51 et seq. to accept the
15 Phase 3 Offer of Improvements and any associated quitclaim deed(s), and dedicate the
16 Phase 3 Public Infrastructure for public use. The PW Director is authorized and directed to
17 take all of the actions and make all of the findings for the Phase 3 Public Infrastructure that
18 were required by the Board in this ordinance for the acceptance of the Phase 2 Public
19 Infrastructure. This includes: as described in Section 4, accepting the Phase 3 Offer of
20 Improvement and Phase 3 Offer of Dedication, dedicating the public improvements for public
21 use, designating the public improvements for public street and roadway purposes, accepting
22 the Phase 3 Public Infrastructure for City maintenance and liability purpose; as described in
23 Sections 5 and 7, establishing official street grades, sidewalk widths, and public right-of-way
24 widths; and as described in Section 2, adopting CEQA, General Plan, and Planning Code
25 Section 101.1 consistency findings.

1 (b) Prior to accepting the Phase 3 Public Infrastructure administratively, the PW
2 Director shall determine in a Public Works Order that all conditions that were required in this
3 ordinance for the Phase 2 acceptance, have been met. In addition, the PW Director shall
4 incorporate into the acceptance conditions, exceptions, or limitations that are in general
5 conformance with what the Board adopted as part of the acceptance of the Phase 2 Public
6 Infrastructure or the PW Director deems necessary and appropriate for any unique attributes
7 of the Phase 3 Public Infrastructure, based on consultation with affected City departments.

8 (c) Upon acceptance under this Section 6 of the Offer of Dedication for Lots 8 and 9 as
9 shown on the Phase 3 Final Map, and their associated grant deeds, the Board of Supervisors
10 hereby authorizes the Director of Property to execute and record said deeds.

11 (d) Upon acceptance under this Section 6 of the Phase 3 Offer of Dedication for the
12 Emergency Vehicle Access Easement and Retaining Wall Access Easement, the Board
13 hereby authorizes the Director of Property to execute and record said easement agreements.
14

15 Section 7. Establishment of Public Right-of-Way Widths, Sidewalk Widths, and Street
16 Grades for Phase 3.

17 (a) The PW Director is authorized to establish the official public right-of-way widths for
18 portions of Fairfax Avenue and Memory Lane as set forth in Public Works Map A-17-247,
19 subject to Section 6 above.

20 (b) Upon issuance of the Public Works Order described in Section 6 above, and in
21 accordance with the PW Order, Ordinance No. 1061, entitled "Regulating the Width of
22 Sidewalks," a copy of which is in the Clerk of the Board Book of General Ordinances, in effect
23 May 11, 1910, shall be amended by adding new Section 1651, to read as follows:

24 Section 1651. The width of sidewalks on portions of Fairfax Avenue and Memory Lane shall be
25 modified as shown on the Public Works Drawing Q-20-1309.

1 (c) The sidewalk widths established herein and in the Public Works Order described in
2 Section 6 above do not obviate, amend, alter, or in any other way affect the maintenance
3 obligations of the adjacent property owners or encroachment permittees as set forth in the
4 Public Works Code.

5 (d) Notwithstanding California Streets and Highways Code Sections 8000 et seq., the
6 Board, in accordance with Administrative Code Sections 1.51 et seq., chooses to follow the
7 City's own procedures for the establishment of street grades. The Board hereby authorizes
8 the PW Director to establish the street grades for portions of Fairfax Avenue and Memory
9 Lane as set forth in Public Works Drawing Q-20-1309, subject to Section 6 above.

10 (e) The Board hereby directs Public Works to revise the Official Public Right-of-Way,
11 Sidewalk Width, and Street Grade maps in accordance with this ordinance.
12

13 Section 8. Authorization for Implementation.

14 The Mayor, Clerk of the Board of Supervisors, Director of Property, PW Director, and
15 County Surveyor are hereby authorized and directed to take any and all actions which they or
16 the City Attorney may deem necessary or advisable in order to effectuate the purpose and
17 intent of this ordinance, including, but not limited to, approving any amended offers of
18 improvements or dedication based on as-built conditions, signing and recording the easement
19 agreements and the deeds for the Street Parcels and improvements, and filing of the
20 ordinance, Public Works Orders, A-17 Maps, and Q-20 Drawings in the Official Records of the
21 City and County of San Francisco.
22

23 Section 9. Effective Date. This ordinance shall become effective on the 31st day after
24 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
25

1 ordinance unsigned or does not sign the ordinance within 10 days of receiving it, or the Board
2 of Supervisors overrides the Mayor's veto of the ordinance.
