9       MOVED, That the certain map entitled "FINAL MAP, PLANNED DEVELOPMENT,  
10 MISSION BAY, (26/28, PHASE II) BEING PHASE TWO OF A SUBDIVISION OF LOT 1 OF  
11 ASSESSOR'S BLOCK 8721 AS SHOWN ON THAT CERTAIN MAP ENTITLED 'MAP OF  
12 MISSION BAY' RECORDED ON JULY 19, 1999 IN BOOK Z OF MAPS AT PAGES 97-119 IN  
13 THE OFFICE OF THE RECORDER OF THE CITY AND COUNTY OF SAN FRANCISCO"  
14 comprising 5 sheets, approved September 28, 2006 by Department of Public Works Order  
15 No. 177,026 is hereby approved and said map is adopted as an Official Final Map Tract 4141  
16 of Mission Bay for Assessor's Block 8721, Lot 1; and be it

17       FURTHER MOVED, That certain public improvements necessitated by the approval of  
18 the Final Map have not been completed at this time, but are being provided by a previous  
19 Public Improvement Agreement between the City and the developer for Mission Bay South  
20 Blocks 26-28, Phase III, dated July 30, 2007, between the City and County of San Francisco  
21 and FOCIL - MB, LLC., a copy of which is in Clerk of the Board File No. 071112; and be it

22       FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own  
23 and incorporates by reference herein as though fully set forth the findings made by the City  
24 Planning Department, by its letter dated October 20, 2000, that the proposed subdivision is

1 consistent with the objectives and policies of the General Plan and the Eight Priority Policies  
2 of Section 101.1 of the Planning Code; and be it

3 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own  
4 and incorporates by reference herein as though fully set forth the findings made by the San  
5 Francisco Redevelopment Agency, by its letter dated October 16, 2000, that the proposed  
6 subdivision is consistent with the Mission Bay South Redevelopment Plan and Plan  
7 Documents (as such term is defined therein); and be it

8 FURTHER MOVED, That the San Francisco Board of Supervisors hereby authorizes  
9 the Director of the Department of Public Works to enter all necessary recording information on  
10 the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerks  
11 statement as set forth herein; and be it

12 FURTHER MOVED, That approval of this map is also conditioned upon compliance by  
13 the subdivider with all applicable provisions of the Mission Bay Subdivision Code and  
14 amendments thereto.


