

1 [Performance Contract Agreement No. 17-94549 - California Department of Health Care  
2 Services - Community Behavioral Health Services - Mental Health Services Act and Various  
3 Programs]

4 **Resolution retroactively authorizing the Department of Public Health, through**  
5 **Community Behavioral Health Services, to enter into Performance Contract**  
6 **No. 17-94549, between the California Department of Health Care Services and**  
7 **Community Behavioral Health Services, incorporating the Mental Health Services Act,**  
8 **Projects for Assistance in Transition from Homelessness, the Mental Health Plan, and**  
9 **Community Mental Health Services Grant for the period of July 1, 2017, through June**  
10 **30, 2018.**

12 WHEREAS, The California Department of Health Care Services (DHCS) administers  
13 funding for the Mental Health Services Act (MHSA), Projects for Assistance in Transition from  
14 Homelessness (PATH), the Mental Health Plan, and Community Mental Health Block Grant  
15 programs; and

16 WHEREAS, The Mental Health Plan was established pursuant to Welfare and  
17 Institutions Code, Section 14726 through 14712, direct the California Department of Health  
18 Care Services to implement and administer Managed Mental Health Care for Medi-Cal eligible  
19 residents of this state through contracts with mental health plans; and

20 WHEREAS, The Mental Health Services Fund was established pursuant to Welfare  
21 and Institutions Code, Section 5890, and provides funds to counties for the implementation of  
22 its MHSA programs for prevention and early intervention, community services and supports  
23 workforce development and training, innovation, plus capital facilities and technological  
24 needs; and

1           WHEREAS, Pursuant to United States Code, Title 42, Sections 290cc-21 through  
2 290cc-35; the PATH grant funds community based outreach, mental health and substance  
3 use disorder referral/treatment, case management and other support services, as well as a  
4 limited set of housing services for the homeless mentally ill; and

5           WHEREAS, DHCS awards federal Community Mental Health Block Grant funds to  
6 counties in California to provide services to the following target populations: children and  
7 youth with serious emotional disturbances, adults and older adults with serious mental  
8 illnesses; and

9           WHEREAS, The County's performance contract, a copy of which is on file with the  
10 Clerk of the Board of Supervisors in File No. 171159, as required by Welfare and Institutions  
11 Code, Sections 5650(a), 5847, and Title 9, California Code of Regulations, Section 3310, sets  
12 forth conditions and requirements the County must meet in order to receive this funding; now,  
13 therefore, be it

14           RESOLVED, That the Department of Public Health (DPH) is hereby retroactively  
15 authorized to enter into a performance contract agreement with DHCS; and, be it

16           FURTHER RESOLVED, That the Board of Supervisors hereby retroactively designates  
17 the Director of Community Behavioral Health Services to sign said agreement on behalf of  
18 DPH; and, be it

19           FURTHER RESOLVED, That within thirty (30) days of the performance contract being  
20 fully executed by all parties the Director of Community Behavioral Health Services shall  
21 provide the performance contract to the Clerk of the Board for inclusion into the official file.
