WHEREAS, On December 1, 2004 the Board of Supervisors passed Resolution #041359 establishing the Western SoMa Citizens Planning Task Force for a period of 3 years; and

WHEREAS, On April 11, 2008 the Board of Supervisors passed Resolution #150-08 extending the life of the Task Force to June 30, 2009; and

WHEREAS, On June 16, 2009 the Board of Supervisors passed File # 090804 extending the life of the Task Force to June 30, 2010; and

WHEREAS, On March 9, 2010 the Board of Supervisors passed File # 100237 extending the life of the Task Force to December 31, 2011; and

WHEREAS, The draft Western SoMa Community Plan was presented to the South of Market community at a Town Hall meeting on April 23, 2008; and

WHEREAS, The draft Western SoMa Community Plan was presented to the Planning Commission on September 18, 2008, initiating a series of public hearings and environment review; and

WHEREAS, The draft Western SoMa Community Plan was unanimously endorsed by the Western SoMa Citizens Planning Task Force on October 22, 2008; and

WHEREAS, The draft Western SoMa Community Plan was presented to the Land Use and Economic Development Committee of the Board of Supervisors on April 20, 2009; and

WHEREAS, The Western SoMa Citizens Planning Task Force has completed all its deliverables in a timely manner; and

WHEREAS, The Western SoMa Citizens Planning Task Force continues to meet to refine their plans; and

WHEREAS, The Western SoMa Citizens Planning Task Force is waiting for completion of the Environmental Impact Report by the Major Environmental Analysis of the Planning Department and because of this there is a need to extend the life of the Task Force; now, therefore, be it
