3 **Ordinance authorizing settlement of the lawsuit filed by Christina Yiu and Jeremy Yiu**  
4 **against the City and County of San Francisco for \$135,000; the lawsuit was filed on**  
5 **December 4, 2019, in San Francisco Superior Court, Case No. CGC-19-581298; entitled**  
6 **Christina Yiu, et al. v. City and County of San Francisco, et al.; the lawsuit involves**  
7 **alleged personal injury arising from a motor vehicle accident.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Christina Yiu, et al. v. City and County  
12 of San Francisco, et al, San Francisco Superior Court, Case No. CGC-19-581298 by the  
13 payment of \$135,000. The lawsuit involves alleged personal injury arising out of a motor  
14 vehicle accident.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 December 4, 2019, and the following parties were named in the lawsuit: Plaintiffs Christina  
17 Yiu and Jeremy Yiu; Defendants City and County of San Francisco and Raymond Whitley.
