3 **Ordinance authorizing settlement of the lawsuit filed by Jennifer Galarza against the**
4 **City and County of San Francisco for \$100,000; the lawsuit was filed on**
5 **September 7, 2018, in San Francisco Superior Court, Case No. CGC-18-569532; entitled**
6 **Jennifer Galarza v. City and County of San Francisco, et al.; the lawsuit involves an**
7 **employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Jennifer Galarza v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-569532, by the
13 payment of \$100,000. The lawsuit involves an employment dispute.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 September 7, 2018, and the following parties were named in the lawsuit: Plaintiff: Jennifer
17 Galarza; Defendants: City and County of San Francisco, James Meikle, Taylor Manfredi,
