3 **Ordinance authorizing settlement of the lawsuit filed by Alyonik Hrushow against the**  
4 **City and County of San Francisco for \$225,000; the lawsuit was filed on August 29,**  
5 **2024, in San Francisco Superior Court, Case No. CGC-24-617659; entitled Alyonik**  
6 **Hrushow v. City of San Francisco, et al.; the lawsuit involves alleged personal injury on**  
7 **a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Alyonik Hrushow v. City of San  
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-24-617659 by the payment of  
13 \$225,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 August 29, 2024, and the following parties were named in the lawsuit: Plaintiff Alyonik  
16 Hrushow; Defendant City of San Francisco, County of San Francisco, San Francisco Public  
17 Works.
