4 **Motion disapproving the determination by the Planning Department that the 2462-27<sup>th</sup>**  
5 **Avenue project is categorically exempt from environmental review under the California**  
6 **Environmental Quality Act.**

8 WHEREAS, On January 16, 2007, the San Francisco Planning Department stamped  
9 as exempt from environmental review under the California Environmental Quality Act (the  
10 "determination"), a building permit application for a third floor and rear extension to an existing  
11 single-family home at 2462-27<sup>th</sup> Avenue (the "Project"). A copy of said document is on file  
12 with the Clerk of the Board of Supervisors in File No. 070694, and is incorporated by  
13 reference herein; and,

14 WHEREAS, By letter to the Clerk of the Board of Supervisors dated May 15, 2007,  
15 Stephen M. Williams filed an appeal of the determination to the Board of Supervisors, which  
16 the Clerk of the Board of Supervisors received on or around May 15, 2007; and,

17 WHEREAS, On June 26, 2007, this Board held a duly noticed public hearing to  
18 consider the appeal of the determination; and,

19 WHEREAS, This Board has reviewed and considered the determination, the appeal  
20 letter, the responses to concerns document that the Planning Department prepared, and  
21 public testimony; and,

22 WHEREAS, The determination files and all correspondence and other documents have  
23 been made available for review by this Board and the public. These files are available for  
24 public review by appointment at the Planning Department offices at 1650 Mission Street, and  
25 are part of the record before this Board by reference herein; now, therefore, be it
