3 **Ordinance approving a fee schedule for ambulance services provided by the San**

7 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The Board of Supervisors approves the following fee schedule for Fire  
10 Department ambulance services:

11 For Basic Life Services, a fee of \$414 per call.

12 For Advanced Life Services, a fee of \$605 per call.

13

14 Section 2. Beginning with fiscal year 2003-2004, fees set in this Ordinance may be  
15 adjusted each year, without further action by the Board of Supervisors, to reflect changes in  
16 the relevant Consumer Price Index, as determined by the Controller.

17 No later than April 15th of each year, Fire Department shall submit its current fee  
18 schedule to the Controller, who shall apply the price index adjustment to produce a new fee  
19 schedule for the following year.

20 No later than May 15th of each year, the Controller shall file a report with the Board of  
21 Supervisors reporting the fee new schedule and certifying that: (a) the fees produce sufficient



1 revenue to support the costs of providing the services for which each fee is assessed, and (b)  
2 the fees do not produce revenue which is significantly more than the costs of providing the  
3 services for which each fee is assessed.


