

10 WHEREAS, The State of California, through various federal homeland security grant
11 programs, provides support for the development and maintenance of the capability of local
12 jurisdictions to prepare for and respond to disasters and provides for the dispersal of federal
13 funds provided for this purpose; and

14 WHEREAS, The City and County of San Francisco has participated in these programs
15 since their inception and deems participation in these programs as vital to the continued well-
16 being of its residents and visitors, property and environment; and,

17 WHEREAS, the Emergency Operation Center grant program provides federal funds to
18 local government to upgrade their emergency operations centers; and,

19 WHEREAS, The State of California requires that San Francisco's agents be named in
20 a governing body resolution, now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco, a
22 public entity established under the laws of the State of California, authorizes the Executive
23 Director of the Department of Emergency Management, or in his or her absence, the Chief
24 Financial Officer of the Department of Emergency Management, or the Deputy Director of the
25 Department of Emergency Management, to execute for and on behalf of the City and County
