3 Ordinance authorizing settlement of the lawsuit filed by Innsbruck, LP against the City  
4 and County of San Francisco for \$1,557,420 plus interest; the lawsuit was filed on  
5 May 14, 2018, in San Francisco Superior Court, Case No. CGC-18-566560; entitled  
6 Innsbruck, LP v. City and County of San Francisco, et al.; the lawsuit involves a  
7 transfer tax refund.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Innsbruck, LP v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-566560 by the  
13 payment of \$1,557,420 plus interest. The lawsuit involves a transfer tax refund.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 May 14, 2018, and the following parties were named in the lawsuit: Innsbruck, LP, plaintiff,  
16 City and County of San Francisco, José Cisneros, Treasurer of The City and County of San  
17 Francisco, David Augustine, Tax Collector of The City and County of San Francisco,  
18 defendants.




