6 **Francisco Department of Public Works, et al.; the lawsuit involves alleged personal**
7 **injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Jane Swigart v. San Francisco
12 Department of Public Works, et al., San Francisco Superior Court, Case No. CGC-22-598721
13 by the payment of \$150,000. The lawsuit involves alleged personal injury on a City sidewalk.

15 March 16, 2022, and the following parties were named in the lawsuit: Jane Swigart, Plaintiff,
