11 alcoholic beverage control license for Polk and Green Produce Market located at 2222  
12 Polk Street; and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
20 off-sale general alcoholic beverage control license from 627 Vallejo Street to 2222 Polk  
21 Street for Michael Dabit for Polk and Green Produce Market, will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) Petitioners shall not permit patrons or the general public to loiter  
24 or congregate on the sidewalks adjacent to the licensed premises; (2) The petitioner(s)  
25 shall be responsible for maintaining free of litter the area adjacent to the premises over

1 which they have control; (3) Sales and service of alcoholic beverages shall be permitted  
2 only between the hours of 8:00 a.m. and 11:00 p.m. each day of the week.


