10 WHEREAS, Ebb & Flow, Inc. is seeking the issuance of a Type-42 on-sale beer  
11 and wine public premises liquor license, to do business as Ebb & Flow, located at 294  
12 Ivy Street (District 5); and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed two protests and zero letters of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
21 to prevent the loitering of persons on any property adjacent to the licensed premises as  
22 depicted on the most recently certified ABC-253; and 2) No noise shall be audible at  
23 any nearby residence or consideration point; now, therefore, be it
