3 **Resolution authorizing the San Francisco Department of Public Health (DPH), to accept**
4 **and expend retroactively a grant in the amount of \$119,181 from the University of**
5 **California, San Francisco (UCSF), to support a study entitled "International Mobility of**
6 **HIV," for the period of September 30, 2007 through August 31, 2008.**

8 WHEREAS, UCSF is the recipient of a grant award from the National Institutes of
9 Health (NIH) for a study entitled "International Mobility of HIV;" and,

10 WHEREAS, It is considered in the best interest of NIH, UCSF, and DPH to participate
11 in this project; and,

12 WHEREAS, UCSF has agreed to reimburse DPH in the amount of \$119,181 under the
13 terms of this agreement for the period of September 1, 2007 through August 31, 2008, and
14 UCSF will extend the project three additional years (through August 31, 2011) if funds are
15 available and satisfactory progress is made; and,

16 WHEREAS, As a condition of receiving the funds UCSF requires DPH to enter into a
17 subaward agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board
18 of Supervisors in File No. 080560, which is hereby declared to be a part of this
19 resolution as if set forth fully within; and,

20 WHEREAS, The grant does not require an ASO amendment and partially reimburses
21 the department for three existing positions, including one Sr. Physician Specialist (Job Class
22 #2232) at .05 FTE, one Epidemiologist II (Job Class #2803) at .50 FTE, one Health Program
23 Coordinator III (Job Class #2593) at .05 FTE for the period of September 30, 2007 through
24 August 31, 2008; and,

7 "International Mobility of HIV;" and, be it


8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
