5 **operations, including submittal of written performance reports to the Board of**  
6 **Supervisors and the Mayor; amending the Health Code to revise and clarify outdated**  
7 **terms concerning refuse receptacle requirements and authorize a process for the**  
8 **imposition of administrative fines; and affirming the Planning Department's**  
9 **determination under the California Environmental Quality Act.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Environmental Findings. The Planning Department has determined that the  
19 actions contemplated in this ordinance comply with the California Environmental Quality Act  
20 (California Public Resources Code Sections 21000 et seq.). Said determination is on file with  
21 the Clerk of the Board of Supervisors in File No. 251254 and is incorporated herein by  
22 reference. The Board affirms this determination.

23 Section 2. General Background and Findings.

24 (a) The Department of Public Works ("Public Works") routinely performs significant  
25

1 operations to ensure the cleanliness of sidewalks, roadways, and other public right-of-way  
2 infrastructure in San Francisco.

3 (b) Public Works provides routine mechanical street sweeping services to clean  
4 approximately 90% of San Francisco streets. Mechanical street sweepers remove litter from  
5 residential neighborhoods and shopping corridors. The process prevents grime and pollutants  
6 from entering the City’s combined sewer system, reducing the quantity of pollutants to be  
7 treated in the City’s water treatment facilities.

8 (c) On October 29, 2025, the Budget and Legislative Analyst’s Office published a  
9 report titled, “Performance Audit of the Management of Street Cleaning by San Francisco  
10 Public Works.” This report concluded, in part, that the absence of a “comprehensive citywide  
11 evaluation [of mechanical street sweeping operations] means that outdated service patterns  
12 may persist, leading to inefficiencies related to cleanliness and cost” and that due to the lack  
13 of a comprehensive evaluation, “optimized route scheduling, frequency, and labor needs”  
14 have not been determined. Also, the report recommended that Public Works “incorporate  
15 specific and routine street sweeping optimization efforts into its operational planning so that  
16 the Department is better equipped to respond to changing street conditions over time.”

17 (d) Public Works’ cleaning and maintenance operations include enforcing laws against  
18 littering on sidewalks. Certain provisions of the Municipal Code intended to prohibit and  
19 address littering are outdated and should be revised to improve clarity, understanding, and  
20 enforcement. ~~In addition, Public Works may benefit from additional enforcement authority  
21 under Administrative Code Chapter 100, which creates a process for the issuance of citations  
22 and administrative fines for violations of certain provisions of the Municipal Code.~~

23  
24 Section 3. The Administrative Code is hereby amended by adding Chapter 55,  
25 consisting of Sections 55.1 and 55.2, to read as follows:

1  
2 **CHAPTER 55: MECHANICAL STREET SWEEPING**

3 **SEC. 55.1. BACKGROUND.**

4 (a) The Department of Public Works (“Public Works” or “Department”) provides routine  
5 mechanical street sweeping services to clean approximately 90% of San Francisco streets. Mechanical  
6 street sweepers remove litter from residential neighborhoods and shopping corridors. The process  
7 prevents grime and pollutants from entering the City’s combined sewer system, reducing the quantity of  
8 pollutants to be treated in the City’s water treatment facilities.

9 (b) Routine evaluation of mechanical street sweeping operations can better equip Public Works  
10 to optimize its operational planning and response to changing street conditions over time.

11  
12 **SEC. 55.2. EVALUATION OF MECHANICAL STREET SWEEPING OPERATIONS.**

13 (a) Periodic Reporting on Performance and Recommendations. At least once every ten years,  
14 the Director of Public Works or the Director’s designee (“Director”) shall submit to the Board of  
15 Supervisors and the Mayor, and publish on the Department’s website, a written report evaluating the  
16 Department’s mechanical street sweeping operations. The report shall include the information  
17 identified in subsection (b) of this Section 55.2 and include findings and recommendations on how the  
18 Department may improve the performance of mechanical street sweeping operations.

19 (b) Performance Criteria. The written report may measure performance based on the  
20 following criteria and any other criteria that the Director determines to be relevant to evaluate  
21 mechanical street sweeping operations:

22 (1) effectiveness and efficiency of mechanical street sweeping equipment;

23 (2) estimated average quantity of debris collected per block, season, mile, or supervisor  
24 district;

25 (3) number of requests and complaints from the public concerning street sweeping

1 operations; and

2 (4) rate of route completion as scheduled, including frequency that scheduled street  
3 sweeping is not completed and frequency that scheduled street sweeping is delayed.

4 (c) **Effects of Other Factors.** The written report may consider the effects of the following  
5 factors, and any other factors the Director deems relevant, on the effectiveness of mechanical street  
6 sweeping operations:

7 (1) traffic volume;

8 (2) land use;

9 (3) sediment and trash accumulation;

10 (4) proximity to bodies of water;

11 (5) illegal parking;

12 (6) traffic control devices in the roadway and bicycle lanes; and

13 (7) the Shared Spaces program, including blocks where mechanical street sweeping is  
14 infeasible due to conflicts with the Shared Spaces Program.

15 (d) **Recommendations.** Each written report shall include recommendations on how to improve  
16 the performance of mechanical street sweeping operations, including proposed changes to staffing and  
17 the mechanical street sweeping schedule.

18 (e) **Initial Report; Subsequent Reports.** The Department shall submit its initial written report  
19 to the Board of Supervisors and the Mayor no later than March 31, 2027. Thereafter, the Department  
20 shall submit a written report to the Board of Supervisors every ten years.

21  
22 Section 4. Article 6 of the Health Code is hereby amended by revising Sections 283  
23 and 283.1 to read as follows:

24  
25 **SEC. 283. CONTAINERIZATION AND BINDING OF REFUSE.**

1 No commercial establishment, dwelling, ~~householder~~ or other person or entity shall store  
2 or place out for collection any refuse that ~~is subject to putrefaction~~ may decompose, decay, rot,  
3 and/or produce odors, including putrescible wastes, as defined in Section 17381 of Title 14 of the  
4 California Code of Regulations, as may be amended from time to time, and any other refuse  
5 destined for disposal, unless it is contained or secured to prevent pets and other animals from  
6 gaining access to its contents and to prevent its dispersal by the wind or other elements.  
7 Other than cardboard boxes that are destined for disposal, ~~a~~All refuse ~~other than cardboard boxes~~  
8 ~~that are destined for disposal~~ and all putrescible ~~wastes~~ refuse must be placed in suitable metal or  
9 solid plastic receptacles. Plastic bags not ~~otherwise~~ contained in metal or solid plastic  
10 receptacles shall not ~~in themselves~~ constitute suitable receptacles. The contents of suitable  
11 receptacles for ~~putrescible refuse and~~ refuse destined for disposal shall not extend above the  
12 top or rim thereof, and shall be contained by tight-fitting lids or sealed enclosures. Cardboard  
13 boxes need not be contained provided they are emptied, flattened, and tied into bundles of  
14 sufficient size to prevent their dispersal by the wind.

15  
16 **SEC. 283.1. PENALTY.**

17 Section 283 of this Article 6 may be enforced using ~~any~~ either of the following processes:

18 (a) **Infractions.** Any person, firm or corporation violating any of the provisions of  
19 Section 283 ~~of this Article~~ shall be guilty of an infraction and, upon conviction thereof, shall be  
20 punished for the first offense by a fine of not less than \$80 nor more than \$100; and for a  
21 second offense by a fine of not less than \$150 nor more than \$200; and for each additional  
22 offense by a fine of not less than \$250 nor more than \$500.

23 (b) **Administrative Citations Under Police Code Section 39-1.** ~~In the alternative, a~~ Any  
24 person, firm or corporation violating any of the provisions of Section 283 of this Article may be  
25 assessed an administrative penalty not to exceed \$1,000 for each violation. Such penalty

1 shall be assessed, enforced and collected in accordance with Section 39-1 of the Police  
2 Code.

3 ~~(e) **Administrative Citations Under Chapter 100 of the Administrative Code.** Any~~  
4 ~~violation of Section 283 shall be deemed a public nuisance. Public Works is authorized to~~  
5 ~~issue administrative citations for violations of Section 283 under Administrative Code Chapter~~  
6 ~~100, which is hereby incorporated in its entirety.~~

7  
8 Section 5. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
9 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
10 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
11 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
12 additions, and Board amendment deletions in accordance with the “Note” that appears under  
13 the official title of the ordinance.

14  
15 Section 6. Effective Date. This ordinance shall become effective at 12:00 a.m. on the  
16 31~~st~~<sup>th</sup> days after enactment. Enactment occurs when the Mayor signs the ordinance, the  
17 Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of  
18 receiving it, or the Board of Supervisors overrides the Mayor’s veto of the ordinance.

**REVISED LEGISLATIVE DIGEST**  
*(Amended in Committee, 3/12/26)*

[Administrative, Health Codes - Mechanical Street Sweeping Performance; Refuse Receptacles]

**Ordinance amending the Administrative Code to require the Department of Public Works to perform evaluations and report periodically on mechanical street sweeping operations, including submittal of written performance reports to the Board of Supervisors and the Mayor; amending the Health Code to revise and clarify outdated terms concerning refuse receptacle requirements; and affirming the Planning Department’s determination under the California Environmental Quality Act.**

Existing Law

Currently, the Municipal Code does not require the Department of Public Works (“Public Works”) to perform evaluations and periodic reporting on mechanical street sweeping operations.

Currently, the Health Code’s requirements concerning the storage and placement of refuse receptacles for collection and disposal include outdated and potentially confusing language.

Amendments to Current Law

This ordinance would amend the Administrative Code to require the Public Works Director or the Director’s designee to submit to the Board of Supervisors and the Mayor, and publish on the Public Works’ website, a written report evaluating Public Works’ mechanical street sweeping operations at least once every ten years, with the first written report due no later than March 31, 2027. The reports would include findings and recommendations on how Public Works may improve the performance of mechanical street sweeping operations.

In addition, this ordinance would amend the Health Code to clarify the garbage receptacle requirements.

Background Information

Public Works provides routine mechanical street sweeping services to clean approximately 90 percent of San Francisco streets. Mechanical street sweepers remove litter from residential neighborhoods and shopping corridors.

On October 29, 2025, the Budget and Legislative Analyst’s Office published a report titled, “Performance Audit of the Management of Street Cleaning by San Francisco Public Works.”

This report concluded, in part, that the absence of a “comprehensive citywide evaluation [of mechanical street sweeping operations] means that outdated service patterns may persist, leading to inefficiencies related to cleanliness and cost” and that due to the lack of a comprehensive evaluation, “optimized route scheduling, frequency, and labor needs” have not been determined. This ordinance would implement some recommendations identified in the report.

This ordinance reflects amendments made by the Public Safety and Neighborhood Services Committee on March 12, 2026.

**Re: Letter of Support for File No. 251254 – Ordinance Amending the Administrative Code (Mechanical Street Sweeping Performance Evaluations and Reporting) and the Health Code (Refuse Receptacles and Administrative Fines)**

Dear Honorable Members of the Board of Supervisors:

The Alliance for a Better District 6 writes in strong support of File No. 251254, the ordinance that requires the Department of Public Works to conduct periodic evaluations and submit written performance reports on mechanical street sweeping operations, while also updating outdated Health Code provisions on refuse receptacles and authorizing administrative fines.

This legislation is a critical step forward because the City must evaluate its performance in many ongoing tasks—particularly in the areas of Administrative and Health Codes concerning Mechanical Street Sweeping Performance and Refuse Receptacles. Public Works currently provides mechanical street sweeping services to approximately 90 percent of San Francisco’s streets, removing litter from residential neighborhoods and shopping corridors throughout Districts 3, 5, & 6. Yet, as the Budget and Legislative Analyst’s Office Performance Audit of October 29, 2025, clearly documented, the absence of comprehensive, regular evaluations has allowed outdated service patterns to persist, creating inefficiencies in cleanliness, cost, route scheduling, frequency, and labor allocation.

By mandating that the Public Works Director (or designee) submit a written report to the Board of Supervisors and the Mayor at least every ten years—with the first report due no later than January 31, 2027—along with findings and actionable

recommendations for improvement, and by providing the Controller's City Services Auditor an opportunity to review and comment, this ordinance directly implements key recommendations from the 2025 audit. It brings long-overdue accountability and data-driven decision-making to an essential public service that directly affects the quality of life in Districts 3,5, & 6.

The ordinance also modernizes the Health Code by clarifying requirements for the storage and placement of refuse receptacles and establishing a fair, efficient process for imposing administrative fines on violations. These updates will reduce confusion, improve compliance, and strengthen enforcement without unnecessary burden on residents or businesses.

The Alliance for a Better District 6 membership believes that requiring regular performance evaluations and clearer, enforceable standards should become standard practice across City departments. We urge the Board of Supervisors to pass File No. 251254 promptly so that San Francisco can deliver cleaner, more efficiently managed streets and more effective refuse management for all our neighborhoods. Thank you for your leadership and for considering this important measure.

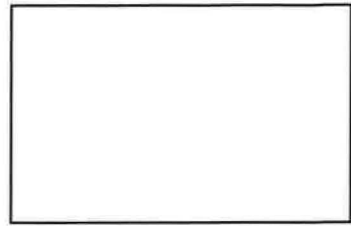
