3 **Resolution determining that the transfer of a Type-48 on-sale general public**  
4 **premises liquor license to Pacific Cocktail Haven at 550 Sutter Street (District 3),**  
5 **will serve the public convenience or necessity of the City and County of San**  
6 **Francisco; and requesting that the California Department of Alcoholic Beverage**  
7 **Control impose conditions on the issuance of the license.**

9 WHEREAS, Pacific Cocktail Haven is seeking the transfer of a Type-48 on-sale  
10 general public premises liquor license to do business as Pacific Cocktail Haven, located  
11 at 550 Sutter Street (District 3); and

12 WHEREAS, The Planning Department has verified that the area is properly  
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero protests and zero letters of  
15 support with the Department of Alcoholic Beverage Control under California Business  
16 and Professions Code, Section 24013, and recommends that the Department of  
17 Alcoholic Beverage Control issue the liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department are the  
19 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
20 to prevent the loitering of persons on any property adjacent to the licensed premises as  
21 depicted on ABC-253; 2) no noise shall be audible at any nearby residence; 3) when the  
22 said outdoor patio area of the premises is being utilized for the sales, service and  
23 consumption of alcoholic beverages, a premise employee shall be in attendance and  
24 maintain continuous supervision at all times of said area to ensure orderly conduct of  
25 patrons; and 4) sales, service and consumption of alcoholic beverages on the patio area

1 shall be only be permitted between the hours of 12:00 p.m. and 10:00 p.m. daily; now,  
2 therefore, be it

3           RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines that transfer of a Type-48 on-sale general public premises liquor  
6 license to Pacific Cocktail Haven located at 550 Sutter Street (District 3), will serve the  
7 public convenience or necessity of the City and County of San Francisco; and, be it

8           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
9 San Francisco hereby endorses and adopts the recommendations of the Police  
10 Department listed above and recommends that the Department of Alcoholic Beverage  
11 Control issue the license with those conditions.
