3 **Resolution naming the 17<sup>th</sup> Street pedestrian plaza located at the intersection of 17<sup>th</sup>**  
4 **Street, Castro Street and Market Street as Jane Warner Plaza.**

6 WHEREAS, Officer Jane Warner dedicated her life to protecting the peace and serving  
7 communities from Hawaii to San Francisco; and

8 WHEREAS, Officer Jane Warner began her career in San Francisco as a Patrol  
9 Special Police Officer in the Castro in 1993; and

10 WHEREAS, Officer Jane Warner who was known by all in the communities she  
11 protected as "Officer Jane"; and,

12 WHEREAS, In 2005, Officer Jane Warner became President of the San Francisco  
13 Patrol Special Police Officers' Association where she advocated on behalf of the Patrol  
14 Special Police to the Board of Supervisors and San Francisco Police Commission; and

15 WHEREAS, Officer Jane Warner was a regular fixture at Community and Civic  
16 meetings whether in the Castro, Noe Valley, Glen Park or the Mission; and

17 WHEREAS, Officer Jane Warner's dedication to the safety of the Community was also  
18 displaced as the longtime writer for the Crime and Punishment column in *The Bay Area*  
19 *Reporter*, and

20 WHEREAS, Sadly, after a yearlong battle with ovarian cancer, Officer Jane Warner  
21 passed away on Saturday May 8<sup>th</sup>, 2010 in her San Francisco home with her wife and mother;

23 WHEREAS, Officer Jane Warner will be missed by the countless residents and  
24 businesses she protected in the Castro, Noe Valley, Glen Park and the Mission as well as  
25 thousands of other people she touched through the years; now, therefore, be it
