5 **filed on June 27, 2023, in San Francisco Superior Court, Case No. CGC-23-607295;**
6 **entitled Elise Williams, et al. v. City and County of San Francisco, et al.; the lawsuit**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Elise Williams, et al. v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-607295 by
13 the payment of \$35,000. The lawsuit involves alleged personal injury on a City street.
