3 **Resolution extending the Asthma Task Force to June 30, 2008.**

5 WHEREAS, the San Francisco Asthma Task Force completed and has made  
6 significant headway in implementation of the Strategic Plan on Asthma for the City and  
7 County of San Francisco in May 2003 which contains recommendations for legislative action  
8 and city-wide strategies to manage and prevent asthma in the city and county of San  
9 Francisco; and,

10 WHEREAS, the Asthma Task Force garnered further recognition and support for future  
11 policy advocacy work with an additional \$300,000 grant for three years from the California  
12 Endowment expected in June 2005, which the American Lung Association helped to secure  
13 on behalf of the Asthma Task Force; and,

14 WHEREAS, through the grant, a fully dedicated asthma advocacy coordinator will  
15 continue to provide staffing support to the task force to ensure implementation of the strategic  
16 plan; and,

17 WHEREAS, significant policy changes have been adopted by the school district and  
18 significant steps have been taken in partnership with the San Francisco Housing Authority;  
19 and,

20 WHEREAS, the grant from the California Endowment will continue to fund strategies  
21 from the plan that focus on reducing environmental risk factors faced by school-aged children  
22 with asthma; and,

23 WHEREAS, the Asthma Task Force is well immersed in the implementation process  
24 but needs additional time to ensure follow-through on implementation of policies passed and

1 secure the investment made to take full advantage of the opportunities provided by the grant  
2 from the California Endowment; and,

3 WHEREAS, an extension to the Asthma Task Force's existence will help to ensure that  
4 the recommendations developed will be properly implemented to ensure the needs of  
5 families, communities, institutions, and the city with regards to asthma management and  
6 prevention are addressed; now, therefore, be it

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 hereby extends the San Francisco Asthma Task Force's existence from July 1, 2005 to June  
9 30, 2008.


