2 URGING THE SAN FRANCISCO OPEN SPACE/PARK RENOVATION CITIZENS
3 ADVISORY COMMITTEE AND THE GENERAL MANAGER OF THE SAN FRANCISCO
4 RECREATION AND PARK DEPARTMENT TO MAINTAIN PRIORITY ONE STATUS FOR
5 THE DEVELOPMENT OF THE EUREKA VALLEY RECREATION CENTER.

7 WHEREAS, The San Francisco Open Space/Park Renovation Citizens Advisory
8 Committee awarded Priority One Status to the Eureka Valley Recreation Center in its Fiscal
9 Year 1998-1999 preliminary budget recommendation; and,

10 WHEREAS, The San Francisco Open Space/Park Renovation Citizens Advisory
11 Committee meets January 5, 1999 to determine the priority for several projects, including the
12 Eureka Valley Recreation Center; and,

13 WHEREAS, The San Francisco Open Space/Park Renovation Citizens Advisory
14 Committee will make its recommendations regarding the Fiscal Year 1999-2000 Priority
15 Status for the Eureka Valley Recreation Center in late Spring of 1999; and,

16 WHEREAS, The Eureka Valley Recreation Center fills a critical need for services for
17 queer youth, including homeless queer youth, through its art and recreation classes; and

18 WHEREAS, The Eureka Valley Recreation Center provides activities ranging from
19 dances to drop-in sessions for youth in the Eureka Valley neighborhood; and,

20 WHEREAS, The Eureka Valley Recreation center is used by a collaborative of several
21 agencies, including the Lavender Youth Recreation and Information Center, to provide
22 constructive activities for youth; and,

23 WHEREAS, The Eureka Valley Recreation Center provides invaluable services, such
24 as a venue for community meetings and workshops, to the Eureka Valley neighborhood and
25 the City in general; now, therefore, be it

1 RESOLVED, That The Board of Supervisors for the City and County of San Francisco
2 urges the Open Space/Park Renovation Citizens Advisory Committee to maintain Priority One
3 Status for the Eureka Valley Recreation Center; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors for the City and County of San
5 Francisco urges the General Manager of the San Francisco Recreation and Park Department
6 to maintain Priority One Status recommendation to the San Francisco Recreation and Park
7 Commission and the Planning Commission.


