3 **Ordinance authorizing settlement of the lawsuit filed by Wang Ieng Cheang Che and**
4 **Kim Heng Che against the City and County of San Francisco for \$500,000; the lawsuit**
5 **was filed on January 19, 2024, in San Francisco Superior Court, Case No.**
6 **CGC-24-611766; entitled Wan Ieng Cheang Che, et al. v. Catherine Bonniot, et al.; the**
7 **lawsuit involves alleged personal injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Wan Ieng Cheang Che, et al. v.
12 Catherine Bonniot, et al., San Francisco County Superior Court, Case No. CGC-24-611766 by
13 the payment of \$500,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco County Superior Court
15 on January 19, 2024, and the following parties were named in the lawsuit: Plaintiffs Wan Ieng
16 Cheang Che and Kim Heng Che; Defendants: Catherine Bonniot and City and County of San
