7 WHEREAS, The Metropolitan Transportation Commission is authorized to make bridge  
8 toll net revenue available pursuant to the Assembly Bill 664 (AB 664) program; and,

9 WHEREAS, The Municipal Transportation Agency, City and County of San Francisco,  
10 is an eligible claimant for assistance pursuant to the AB 664 program; and,

11 WHEREAS, The AB 664 Bridge Toll Net Revenue program provides for \$4,663,431 of  
12 capital assistance to the Municipal Transportation Agency for Cable Car Vehicle Renovation,  
13 Rail Replacement, Overhead Rehabilitation and Motor Coach Replacement projects; now,  
14 therefore, be it,

15 RESOLVED, That the Board of Supervisors authorizes the Municipal Transportation  
16 Agency to apply for, to accept and expend \$4,663,431 of AB 664 Bridge Toll Net Revenue  
17 Program funds for the purposes of Cable Car Vehicle Renovation, Rail Replacement,  
18 Overhead Rehabilitation and Motor Coach Replacement for the San Francisco Municipal  
19 Railway; and, be it

20 FURTHER RESOLVED, That the Municipal Transportation Agency is authorized to  
21 furnish whatever additional information as may be requested by the funding agencies in  
22 connection with this request.


