

1 [Diagnostic and Treatment Services of Juvenile Ward of the Court]

2 AUTHORIZING THE CHIEF PROBATION OFFICER OF THE JUVENILE
3 PROBATION DEPARTMENT TO RENEW A CONTRACT WITH THE
4 CALIFORNIA YOUTH AUTHORITY FOR DIAGNOSTIC AND TREATMENT
5 SERVICES AND TEMPORARY DETENTION NOT TO EXCEED 90 DAYS;
6 PROVIDING FOR RATIFICATION OF ACTIONS PREVIOUSLY TAKEN.

8 WHEREAS, from time to time, the Juvenile Court may determine that proper
9 disposition of a case requires diagnosis and treatment at a Youth Authority facility; and

10 WHEREAS, after the Juvenile Court has determined that a juvenile ward of the
11 Court is eligible for temporary detention and maximum observation not to exceed 90
12 days; and

13 WHEREAS, the California Youth Authority has agreed to provide temporary
14 detention of a Juvenile ward of the Court for diagnostic and treatment services not to
15 exceed 90 days; and

16 WHEREAS, the term of this contract shall be from July 1, 1998 to June 30, 1999;


19 WHEREAS, the county agrees to reimburse CYA an amount not to exceed
20 \$3300.00 per month and \$35,000 for the year, for each juvenile ward referred and
21 authorized by the Juvenile Court only which shall be paid for from the Probation Services
22 Division Maintenance of Minors Appropriation within the budget of the Juvenile
23 Probation Department; and

WHEREAS, the Juvenile Probation Commission reviewed and approved the
resolution on July 8, 1998, now, therefore, be it

RESOLVED, that the Board of Supervisors hereby approves Resolution No.
696-98, authorizing the Chief Probation Officer to renew a contract with the California
Youth Authority for Juvenile Court referrals only for the period July 1, 1997 to June 30,
1998, said contract subject to review and extension by the Juvenile Probation
Commission; and be it

FURTHER RESOLVED, that although the City has incurred no legal obligation,
the Board of Supervisors does hereby ratify the action previously taken.
