

1 [Accept and Expend Grant - National HIV Behavioral Surveillance - San Francisco - Bio-  
2 Behavioral Surveillance Activities - \$1,025,539]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**  
4 **expend a grant increase of \$466,606 for a total amount of \$1,025,539 from Centers for**  
5 **Disease Control and Prevention to participate in a program, entitled "National HIV**  
6 **Behavioral Surveillance - San Francisco," to continue ongoing bio-behavioral**  
7 **surveillance activities among populations at high risk for HIV infection for the period of**  
8 **January 1, 2018, through December 31, 2018.**

10 WHEREAS, Centers for Disease Control and Prevention has agreed to fund  
11 Department of Public Health (DPH) in the amount of \$1,025,539 for the period of January 1,  
12 2018, through December 31, 2018; and

13 WHEREAS, The full project period of the grant starts on January 1, 2016, and ends on  
14 December 31, 2020, with years four and five subject to availability of funds and satisfactory  
15 progress of the project; and

16 WHEREAS, The purpose of this project is to continue on-going bio-behavioral  
17 surveillance activities among populations at high risk for HIV infection in San Francisco; and

18 WHEREAS, This activity monitors changes in HIV prevalence, incidence and related  
19 risk behaviors; and

20 WHEREAS, Data collected informs HIV prevention and care priorities and planning and  
21 also leads to improvements in HIV prevention programs in order to reduce new infections in  
22 the city; and

23 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

24 WHEREAS, A request for retroactive approval is being sought because DPH received  
25 the full award agreement on August 22, 2018, for a project start date of January 1, 2018; and

1           WHEREAS, The AAO budget for FY2016-2017 was approved in the amount of  
2 \$558,933; and

3           WHEREAS, An increase of \$466,606 from \$558,933 was approved for the period of  
4 January 1, 2018, through December 31, 2018, for a total amount of \$1,025,539; and

5           WHEREAS, The budget includes a provision for indirect costs in the amount of  
6 \$28,455; now, therefore, be it

7           RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant  
8 in the amount of \$1,025,539 from Centers for Disease Control and Prevention; and, be it

9           FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
10 expend the grant funds pursuant to Administrative Code, Section 10.170-1; and, be it

11           FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
12 Agreement on behalf of the City.




