9	Be it ordained by the People of the City and County of San Francisco:
10	Section 1. Findings.
11	(A) Pursuant to Planning Code Section 302, the Board finds that the proposed
12	landmark designation of 900 Innes Avenue (Hunter's Point School) will serve the public
13	necessity, convenience and welfare
14	(B) The Board finds that the proposed landmark designation of 900 Innes Avenue
15	(Hunter's Point School) is consistent with the City's General Plan and with Planning Code
16	Section 101.1(b) for the reasons set forth in the document entitled "Board of Supervisors of
17	the City and County of San Francisco, General Plan Policies and Planning Code Section
18	101.1—General Plan Consistency and Implementation, 900 Innes Avenue (Hunter's Point
19	School)," which is on file with the Clerk of the Board of Supervisors in File No.
20	and is incorporated herein by reference. The Board finds that the proposed
21	landmark designation is consistent with the City's General Plan and with Planning Code
22	Section 101.1(b) for the reasons set forth in said document.
23	(C) The Planning Department has determined that the actions contemplated in this
24	Ordinance are in compliance with the California Environmental Quality Act (California Public
25	

1	Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the
2	Board of Supervisors in File No and is incorporated herein by reference.
3	(D) The Board of Supervisors hereby finds that 900 Innes Avenue (Hunter's Point
4	School) on Lot 003 in Assessor's Block 4646 has a special character and special historical,
5	architectural, and aesthetic interest and value, and that its designation as a Landmark will
6	further the purposes of and conform to the standards set forth in Article 10 of the San
7	Francisco Planning Code.
8	Section 2: Designation. Pursuant to Section 1004 of the Planning Code, 900 Innes
9	Avenue (Hunter's Point School), in Lot 003 of Assessor's Block 4646 is hereby designated as
10	a San Francisco Landmark under Article 10 of the Planning Code. This designation was
11	initiated by Resolution No. 553-04 of the Board of Supervisors on August 25, 2004 and
12	recommended by Resolution No. 588 of the Landmarks Preservation Advisory Board on May
13	4, 2005, which Resolutions are on file with the Clerk of the Board of Supervisors in File No.
14	and which Resolutions are incorporated herein by reference as though fully
15	set forth.
16	Section 3. Required Data.
17	(A) The description, location, and boundary of the Landmark site consists of the City
18	parcel located at Lot 003 in Assessor's Block 4646, with the street address of 900 Innes
19	Avenue (Hunter's Point School).
20	(B) The characteristics of the Landmark that justify its designation are described and
21	shown in the Landmark Designation Report, adopted by the Landmarks Preservation Advisory
22	Board on May 4, 2005 and updated in April 2006, and other supporting materials contained in
23	Planning Department Case Docket No. 2004.0916L. In brief, the National Register of Historic
24	Places characteristics that justify the Landmark's designation are as follows: (1) under

1	National Register of Historic Places Criterion "A", association with historic events, because of
2	the property's association with the historic marine cargo industry and the community of
3	shipwrights that settled India Basin; and (2) under National Register of Historic Places
4	Criterion "C", as an rare remaining example of workman vernacular architecture that includes
5	traits of several Victorian architectural styles.
6	(C) The particular exterior features that shall be preserved, or replaced in-kind as
7	determined necessary, are those generally shown in photographs and described in the
8	Landmark Designation Report, which can be found in Planning Department Docket No.
9	2004.0916L and which is incorporated in this designation by reference as though fully set
10	forth. Specifically, the following features shall be preserved: all of the exterior elements
11	surviving from the original construction including the rustic channel siding, trim, and front entry
12	and window hoods as well as the general massing.
13	Section 4. The property shall be subject to further controls and procedures pursuant to
14	the San Francisco Planning Code and Article 10.
