As an individual, I am a queer, second-generation Filipina American, survivor of gendered and domestic violence, and advocate for sex-positive, consent-positive, harm-reduction, and community-responsive trauma informed systems frameworks. I have been a San Francisco resident for four years, Bay Area Resident for seven years, and have been working and volunteering in the South of Market community since 2016.
I am a community artist, whose practice focuses on contemporary experiences of Filipina immigrants in America, and work with community arts organizations like Kearny Street Workshop, Kularts, and Bindlestiff Studio.

**Business and/or professional experience:**

I am currently the Program Manager of Balay Kreative, a project that was awarded funding by MOHCD in 2019 to develop a new model for a Filipinx American Cultural Center, operated by Kultivate Labs. Previous professional experience also includes Program Manager at Kularts, Production Manager for Skywatchers in the Tenderloin, Southern Exposure's Curatorial Council, and Artist-collaborator with Kearny Street Workshop. As an arts professional, I am committed to collaboratively creating decolonial practices within arts institutions, while creating visibility and providing resources for emerging Asian Pacific American and BIPOC Artists.

I have been in arts & ethnic studies education since 2008, having served over 350+ students at over 23 school sites, primarily working with urban immigrant youth. Previous schools & programs include Pin@y Educational Partnerships, Galing Bata After School Program, Leadership HS, Burton HS, Southern Exposure's Artists in Education Coordinator, and currently, San Francisco State University.

I have participated the past three years for SFWAR's Walk Against Rape, have organized small healing circles for Queer Asian Women specifically around gendered labor and consent called "Bitter Nourishment" with collaborator Thuy Tran, and have advocated for stronger Sexual Assault and Consent policies and trainings in our SOMA Pilipinas community. Since being assaulted by a respected community member, I faced many hurdles in asking for accountability and safety for myself, and it has been an ongoing challenge to advocate for safer, transformative spaces for collective community healing. I have also taken a leadership role in Kultivate Labs' training and integration of Trauma-Informed Systems on an organizational and community level.



Although I currently live in the Sunset District of the City, I have worked and lived in the South-of-Market-Area (SOMA) for over 15 years dating back to 1995.

From 1998 - 2001, I ran a non-profit theatre called Bindlestiff Studio and build it into an essential cultural center for Filipin@ Americans in the performing arts. I, along with our Filipino community helped saved the theater from demolition in 2002. I returned to help run Bindlestiff in 2009 and opened the current Bindlestiff Studio in 2011.

I am still heavily involved with the Filipino American community of the SOMA for over 25 years including the current efforts to establish SOMA Pilipinas as a national model for cultural heritage districts.

**Business and/or professional experience:**

I currently work as a Director of Development for Hospitality House, a progressive community center providing services for people struggling with poverty and homelessness. Three of our six community programs are located in SOMA including an Employment Resources Center (Neighborhood Access Point on Sixth Street), one of our two Self-Help Centers also on Sixth Street, and our Community Arts Program located on the south side of Market Street.

I was also an Artistic and Managing Director of Bindlestiff Studio, a live black box theater located on Sixth Street focused on nurturing Filipino Americans in the performing arts.

I have served on the SOMA Community Stabilization Fund CAC for approximately 10 years, 4 of those years as the Chairperson. Prior to this time, I also served on the South-of-Market Project Area Committee (SOMPAC) before the dissolution of the SF Redevelopment Agency.


I have also served on several grant panels for the San Francisco Arts Commission as well as an advisor for the 2 Blocks of Art produced by Urban Solutions for the City.

One category that is woefully absent is that I am a resident of Soma and have been for almost 20 years. There is a stark difference between being in Soma during work hours and living in Soma 24 hours a day. In my personal and professional experience, I am acquainted with many of the challenges and have actively supported folks struggling with income inequality, learning and physical disabilities and the discrimination faced by the LGBTQ community.

I have over 25 years experience serving SF youth, 15 of those being dedicated to also serving the Bessie Carmichael Community. In my work, I navigate daily various city departments, private/public relationships and the variety of public services in support of the families that we serve who are in dire need of support. 

**Board Qualifications:**

The SOMA Community Stabilization Fund Community Advisory Committee ("Committee") shall advise the Mayor's Office of Housing and Community Development ("MOHCD"), other City agencies, and the Board of Supervisors regarding the following:

- (1) Administration of the SOMA Community Stabilization Fund described in Section 418.7 of the Planning Code;
- (2) Prioritization of funding for social services related to cultural preservation that are funded by proceeds of the Central SoMa Community Facilities District special tax, as defined in Planning Code Section 434 and the Central SoMa Implementation Program;
- (3) Prioritization of community improvement projects and other public investments funded by the Central SoMa Community Services Facilities Fund, established in Planning Code Section 432.4;
- (4) Expenditure of affordable housing fees collected pursuant to Planning Code Section 415, and Jobs-Housing Linkage Fees collected pursuant to Planning Code Section 413, generated from development projects within the boundaries of the East SoMa, Central SoMa, or Western SoMa Area Plans, or within 0.25 miles of the boundaries of said area plans but outside the boundaries of the Showplace Square/Potrero Hill, Mission, Central Waterfront, and Market and Octavia Area Plans.

The Committee shall be composed of seven (7) members and seven (7) alternate members, appointed by the Board of Supervisors that must satisfy at least one of the following requirements:

- > Represents low-income residents of SOMA.
- > Has expertise in employment development and/or represents labor.
- > Is a senior or disabled resident of SOMA.
- > Has affordable housing expertise and familiarity with the SOMA neighborhood.
- > Represents an arts or cultural organization or a cultural district in SOMA.
- > Provides direct services to SOMA residents.
- > Has small business expertise and a familiarity with the SOMA neighborhood; and/or
- > Is a youth or who represents a youth-development organization.

Taken as a whole, the Committee shall meet all of the membership requirements set forth above.

Additional Requirements: Two (2) voting and two (2) alternate members shall live within the boundaries of the East SoMa, Central SoMa or Western SoMa Area Plans.

Term: Four (4) years with a two consecutive term limit.

MOHCD shall provide administrative and clerical support to the Committee.

The Committee shall coordinate with the South of Market Community Planning Advisory Committee established in Administrative Code, Chapter 5, Article XXVI, when providing advice on matters within the programmatic jurisdiction of both committees.

Reports: The Committee shall develop annual recommendations to MOHCD on the Expenditure Plan referenced in Section 418.5(d) of the Planning Code.

Sunset: Unless the Board of Supervisors by ordinance extends the term of the Committee, this Article XXVII shall expire by operation of law, and the Committee shall terminate, on January 1, 2035.
