

1 [Agreement - Supplemental Law Enforcement Services to Housing Authority - FYs 2012-2013
2 and 2013-2014 - \$1,115,000 and \$1,300,000]

3 **Resolution retroactively approving the agreement between the Police Department and**
4 **the Housing Authority for the Police Department to provide Supplemental Law**
5 **Enforcement Services at designated Housing Authority developments and for the**
6 **Housing Authority to pay the City \$1,115,000 in FY2012-2013 and \$1,300,000 in FY2013-**
7 **2014 for those Supplemental Law Enforcement Services.**

9 WHEREAS, The San Francisco Police Department (“SFPD”) provides law enforcement
10 services in the City and County of San Francisco (“City”), including at housing developments
11 and other properties owned and managed by the San Francisco Housing Authority
12 (“Authority”), and

13 WHEREAS, Authority has experienced various levels of crime, including drug and gang
14 problems, at certain of its housing developments, and

15 WHEREAS, It is the common goal of the SFPD and the Authority to provide a
16 supplemental law enforcement program, focused on community policing, to reduce crime and
17 fear of crime in specified Authority housing developments; and

18 WHEREAS, To achieve that common goal, Authority has requested SFPD to provide
19 supplemental law enforcement services to certain designated housing developments, over
20 and above the general law enforcement services that SFPD provides to the public generally;
21 and

22 WHEREAS, The SFPD and Authority have negotiated a two year agreement setting
23 the terms and conditions of the supplemental law enforcement services program for Fiscal
24 Years 2012-2013 and 2013-2014; and,

1 WHEREAS, A copy of the agreement is on file with the Clerk of the Board of
2 Supervisors in File No. _____, which is hereby declared to be a part of this
3 motion as if set forth fully herein; and,

4 WHEREAS, Charter Section 9.118(a) requires Board of Supervisor approval for all
5 contracts having anticipated revenue to the City of one million dollars or more, or the
6 modification, amendment or termination of any contract which when entered into had
7 anticipated revenue of one million dollars or more; and,

8 WHEREAS, Under the agreement, the Authority will pay SFPD \$1,115,000 for
9 supplemental law enforcement services in Fiscal Year 2012-2013 and will pay \$1,300,000 for
10 those services in Fiscal Year 2013-2014, and therefore Board of Supervisors approval for the
11 agreement is required under Charter Section 9.118(a); and;

12 WHEREAS, The revenue from the first year of the agreement is included in the Police
13 Department's Fiscal Year 2012-2013 budget and the revenue for the second year is
14 accounted for in the Fiscal Year 2013-2014 budget; and

15 WHEREAS, At its meeting on December 13, 2012, the San Francisco Housing
16 Authority Board of Commissioners approved the agreement; and,

17 WHEREAS, At its meeting on January 23, 2013, the Police Commission approved the
18 agreement and recommended that the Board of Supervisors approve that agreement; now,
19 therefore, be it

20 RESOLVED, That the Board of Supervisors retroactively approves the agreement
21 between the SFPD and Authority for supplemental law enforcement services for Fiscal Years
22 2012-2013 and 2013-2014.
